- **A survey of n=320 Washington County residents was conducted online in both English (n=317) and Spanish (n=3).**
- **Engagement events were conducted August 1st to September 9th, 2022.**
- **Throughout this report we refer to “younger” and “older” residents. Younger residents are under age 50 and older voters are age 50 and up.**
- **6% of the sample report identifying as Hispanic/Latino/Latina/Latinx**
- **9% of respondents identified as Black, Indigenous, or other people of color.**

The demographics of respondents:



- **Gender:** 53% of respondents were Women; 35% of respondents were Men; 3% of respondents were non-binary/ third gender
- **Age:** 46% of respondents are under 50; 51% of respondents are over 50-years-old
- **Education:** 3% of respondents are high school graduates or less; 19% received some college education; 37% are college graduates; 40% are post graduate degrees
- **Home Ownership:** 86% of respondents are home-owners; 8% are renters
- **WA County Residency:** 15% less than 6 years; 17% 6-10 years; 29% 11-25 years; 40% 25+

N= 320 respondents*

Key findings:



- **Findings from the survey indicate three potential final maps for consideration:**
 1. Plan #4: Community Boundaries: This plan tested best overall (61% support) and was the second-place finisher in the “forced choice” exercise where respondents were asked to pick their favorite of all five plans. It was also well testing amongst BIPOC residents (53% support).
 2. Plan #5: City and UPAA: This plan was the second-best testing (55% support) in direct questioning and was well testing among BIPOC residents (53% support). However, it did not score well in the forced choice exercise.
 3. Plan #3: Urban Rural Balance: This plan was very well testing among BIPOC residents (61% support) and was the top choice in the forced choice exercise. However, it was the lowest scoring in direct questioning (41% support; 52% oppose).
- **Important note:** please consider that there were only n=51 BIPOC respondents in this non-random sample of Washington County residents.

Background information provided to respondents



Every 10 years, Washington County must consider redrawing the boundary lines for county commissioner districts to make sure that everyone's vote has the same value. If one district becomes bigger than the others, the votes in that district are more diluted than the others. The 2020 census showed that District 2 has grown more than the other districts, so we need to make District 2 smaller and the others bigger. We would like your help so that each includes about the same number of people. At the end of this process, the population of the newly redrawn districts must not be more than 103% of any other. Under the Washington County Charter, this process must start as soon as the Oregon Legislature has finished a similar process of redrawing state legislative district lines.

Earlier this year, the Board of County Commissioners asked Portland State University's Population Research Center to provide recommended options for changing the commissioner district boundary lines.







Community Boundaries Plan (#4)

Significant gender, race, and home ownership gaps are prevalent; support margins among all groups remain in the double-digits









City and UPAA Plan (#5)

It also takes into account the planning area boundaries in the unincorporated areas. Urban Planning Area Agreements (UPAAs) are agreements among local jurisdictions to identify the land use planning area around each city and acknowledge responsibilities for comprehensive land use planning activities. This plan holds double-digit support margins across all major subgroups






A significant gap in support based on race emerges; all other subgroups are similarly supportive of this option









Urban Concentration Plan (#2b)

BIPOC voters and renters are strongly opposed to the Urban Concentration Plan; other groups are more divided









Urban/Rural Balance Plan (#3)

This would require some significant changes in the current boundaries. For example, District 2 which now has a western boundary in Hillsboro would extend all the way to the northwest corner of the county. District 4, to add more urban voters, would now extend all the way to Beaverton. What do you think about the “Urban/Rural Balance Plan”?

While opposition mostly sits in the double-digits, renters and BIPOC voters are net supportive of this plan






How the Plans Stack Up

When asked to pick their favorite, the Urban/Rural Balance and Community Boundaries plans come out on top



Note: it's our view that while a slim plurality prefer the "Urban / Rural Balance" Plan in a forced choice scenario, the strength of "Community Boundaries" in direct questioning, and its 2nd place finish in the forced choice exercise, make it the preferred option alongside the "City and UPAA Integrity Plan" which receives significant support from BIPOC residents.

There also may have been some confusion by the time respondents reached this question. Recall may also have been an issue RE plan impact on the community.

While the difference is slim, the Urban/Rural Balance plan nets more support and garners stronger support from renters and BIPOC voters

Those who support the “Community Boundaries Plan,” but opt for the “Urban Rural Balance Plan” when presented all five options:

- Residents of less than 6 years 24%
- Under age 40 20%
- Seniors (over 70) 18%
- Women 16%

- All residents 14%













Si un distrito se vuelve más grande comparado a los otros, los votos en ese distrito se diluyen más que los demás. El censo de 2020 mostró que el Distrito 2 ha crecido más que los otros distritos, por lo que hay que hacer el Distrito 2 más pequeño y los otros más grandes. Nos gustaría contar con su ayuda para que cada uno de los distritos incluya aproximadamente el mismo número de personas. Al final de este proceso, la población de los nuevos distritos reajustados no debe ser superior al 103% comparado a los otros.
