# Appendix C: Implementation Resources and Funding Opportunities

#### 1.1. Overview

Determining current and/or potential implementation resources and funding opportunities for each identified action item is a vital part of the mitigation strategy planning process. By exploring, identifying, and designating funding sources now, jurisdictions are poised to complete identified action items as implementation and funding opportunities arise.

Under the Code of Federal Regulations (CFR) Title 44, Part 201.6 (44 CFR §201.6), Local Mitigation Plans, local governments must have a Federal Emergency Management Agency (FEMA)-approved local mitigation plan in order to apply for and/or receive hazard mitigation project grant funds for the following federal Hazard Mitigation Assistance (HMA) programs:

- Hazard Mitigation Grant Program (HMGP)
- HMGP Post Fire Program
- Building Resilient Infrastructure and Communities (BRIC)
- Flood Mitigation Assistance (FMA)
- Repetitive Flood Claims
- Severe Repetitive Loss

Figure 115 illustrates the FEMA hazard mitigation funding programs available for eligible facilities, such as water treatment plants and transportation systems, under the Robert T. Stafford Disaster Relief and Emergency Assistance Act (Stafford Act) of 1988, HMA, and the National Flood Insurance Act (NFIA) of 1968.

The Oregon Department of Emergency Management (OEM) administers HMA grants on behalf of FEMA. When local jurisdictions in Oregon are interested in applying for non-disaster and post-disaster federal funds, the State Hazard Mitigation Officer (SHMO) can provide guidance and education about available grants and the grant application process. Local jurisdictions should contact the SHMO for additional information.

Mitigation activities can and should be implemented through a variety of funding streams. FEMA funding sources, including Public Assistance, HMGP, the BRIC program, the FMA program, and Sections 404 and 406 of Hazard Mitigation Funding, tend to be relied on heavily for mitigation action completion. However, it is important to research and leverage other available funding opportunities and not to limit funding sources to FEMA assistance programs. Funding opportunities may include other federal agencies; state, local, and tribal programs, as applicable; or private funding (see Table 378 and Table 379). In addition to funding, mitigation implementation resources, such as regulatory and technical assistance, are available to assist jurisdictions in completing action items and integrating mitigation into planning and resilience efforts.




Figure 116: Federal Emergency Management Agency's Hazard Mitigation Assistance Programs

### 1.2. Hazard Mitigation Grant Program

The HMGP is authorized under 44 CFR §206 and Section 404 of the Stafford Act. The purpose of the HMGP is to provide funds to states, territories, tribal governments, and communities to significantly reduce or permanently eliminate future risk to lives and property from natural hazards. Entities pursuing HMGP funding must have a FEMA-approved hazard mitigation plan.

Because the State of Oregon has an enhanced hazard mitigation plan, they are eligible for HMGP funding, which equates to 20% of the federal share of disaster assistance provided after a federally declared disaster. The HMGP funding is broken down into three categories:

- Initiative projects (5%)
- Plan development and revision (7%)
- Regular projects (88%)

The grant application period is open for 12 months after the declaration date. All applications are made through and reviewed by the state and approved by FEMA.

### 1.3. Flood Mitigation Assistance Program

The Oregon Department of Emergency Management (OEM) administers the FMA program. Its purpose is to implement cost-effective measures that reduce or eliminate the long-term risk of flood damage to buildings, manufactured homes, and other structures insured under the National Flood Insurance Program (NFIP).

The FMA funds planning activities that assess a community's flood risk and identify actions to reduce risk. Additionally, FMA funds property acquisitions, structure demolition, structure relocation, and other flood mitigation activities. FEMA may contribute up to 90% federal cost share for eligible costs for activities or projects that address repetitive loss properties and/or are in communities with a social vulnerability index score of 0.5 or more.

#### 1.4. Building Resilient Infrastructure and Communities

The newest FEMA pre-disaster hazard mitigation program replaced the Pre-Disaster Mitigation program. FEMA opened the first BRIC application period during the fiscal year 2020.

BRIC supports communities through capability- and capacity-building, encouraging and enabling innovation, promoting partnerships, enabling large projects, maintaining flexibility, and providing consistency.

Priorities are to fund public infrastructure projects and projects that mitigate risk to one or more community lifelines, incentivize projects that incorporate nature-based solutions, and provide funding to applicants that facilitate the adoption and enforcement of the latest published editions of building codes.

## 1.5. Stafford Act Sections 404 and 406 Allowable Mitigation Activities

Sections 404 and 406 of the Stafford Act established mitigation activities for facilities requiring repair, restoration, or replacement as a result of a federally declared disaster. Although Sections 404 and 406 are distinct programs with key differences in their scope, purpose, and funding, both support hazard mitigation goals.

- **Section 404:** HMGP funding is used to provide protection to undamaged parts of a facility or to prevent or reduce damages caused by future disasters.
- Section 406: Public Assistance Program funding provides authority to fund mitigation measures in conjunction with the repair of the disaster-damaged public and private nonprofit facilities only. This assistance is also limited to declared counties and eligible damaged facilities.

building codes and standards. As a condition of the award, either a disaster-resistant building code must be adopted or an improved Building Code Effectiveness Grading Schedule is required.

### 1.6. Recently Authorized Federal Funding Sources

Recent sources of federal funds that can be used for mitigation actions are the Infrastructure Investment and Jobs Act that was passed by Congress on November 5, 2021, and the Inflation Reduction Act signed into law on August 16, 2022. These acts authorized new and continued infrastructure funding, with a focus on climate resiliency. Transportation investments will repair and rebuild roads and bridges, and new infrastructure investment, primarily to energy infrastructure, will protect against droughts, floods, and wildfires, in addition to extreme weather events. <sup>638,639</sup> The ways in which this legislation will be administered is still being determined at the time this plan was written.
