Hillsboro Graduated Independent Living Program (HGILP aka Hartner House), opened in November 2007 and is under the operation of New Narrative. This 7 SRO unit facility offers permanent-supportive housing for chronically homeless individuals living with severe and persistent mental illness.

The residence is monitored by onsite support staff and provides basic necessities for comfort and safety. Participants in HGILP receive mental health services, case management, counseling and crisis intervention, integrated assessments, prescriber services, medication management, life skills training, employment services, and linkages to benefits, entitlements, community supports, and health care. Participants with co-occurring disorders receive integrated dual diagnosis services, as well as referrals to community partners which specialize in addictions. These services are delivered on-site or at a local New Narrative clinic. Participants complete a Service Plan with the assistance of staff to identify goals, with a general framework of increasing independence and establishing stability in the community. Although residency at Hartner House is open-ended without a timeline for transition, planning for future permanent housing is part of every individuals' treatment plan. In addition to applications for Section 8 rental assistance, participants are also assisted in accessing other resources for affordable housing. As a result of available services, program outcomes include reducing homelessness, decreasing substance abuse and mental health challenges, improving life skills and social functioning, and decreasing interactions with the criminal justice system.

Outreach and referral to the program is conducted in alignment with Community Connect, the CoC coordinated entry system, with a mobile assessment team serving the chronically homeless experiencing a mental health crisis. Community Connect receives referrals from a variety of outreach sources including New Narrative's PATH, Emergency Solutions Grant outreach, the Washington County Mental Health Court, Hawthorn Mental Health Walk-In Center, and partner agencies serving homeless persons who meet the HUD definition of chronic homelessness.

New Narrative is an active participant in the CoC known as the Housing and Supportive Services Network (HSSN), and supports efforts to increase resources and develop systems changes identified in A Road Home Homeless Plan and Home, Together: Federal Strategic Plan to Prevention and End Homelessness. The agency has its own network of housing options ranging from state licensed mental health residences to minimally structured, semi-independent supported housing that are made available to every participant based on individual need. New Narrative has a commitment to help individuals move forward to the most independent level of housing possible. We address specific barriers faced by communities of color and engage in ongoing DEI training/recruitment.

VAWA Budget


