What is the Point in Time Count?

- The Point in Time (PIT) count is a snapshot of homelessness in our County on the night of the PIT count
- Count was conducted 1/30/2024 this year
- HUD requires a Shelter count every year and a Street count every 2 years
- We did not complete a Street count this year and are using supplemental Street Outreach and Coordinated Entry data to estimate the Unsheltered population
- We will only submit the Sheltered Count to HUD this year




Point in Time Count Trends: Sheltered vs. Unsheltered Individuals

% of Individuals Sheltered vs. Unsheltered








% of Individuals per Family Type



Individuals experiencing Chronic Homelessness | 2020 - 2024


