



#### What is the Housing Inventory Chart?

- The Housing Inventory Chart (HIC) is a HUD report that captures a point in time snapshot of the capacity and utilization of all shelter and housing programs serving homeless individuals in our CoC as of the night of the Point in Time (PIT) count
- The HIC does not include Prevention, Coordinated Entry, Street Outreach, or other Services Only programs
- Utilization for Housing Programs is based on the households housed on the night of the PIT and does not include those enrolled but not yet housed
- HUD requires that all RRH units and beds are calculated based on those housed on the night of the PIT, always resulting in 100% utilization



#### How do we Prepare the Housing Inventory Chart?


- The HIC is primarily focused on a count of beds (or people) that are available on the night of the PIT
- The vast majority of our programs are designed to serve a set number of Households, meaning that the beds are fluid based on the number of people in the households that get served
- We forecast beds based on the household (units) utilization rate on the night of the PIT
  - Prior to 2023, we used a different method for forecasting beds that was based on generic average household sizes. This means that year over year comparisons are less meaningful for historical reports.



#### Overview of Housing Inventory

#### Housing Inventory Chart (HIC) as of 1/30/2024

- 2,874 units in shelter & housing, compared to 2,269 units in 2023.
- Programs increased from 76 to 86 YoY.
- 81% utilization in 2024 compared to 83% in 2023.







#### Emergency Shelter HIC

81% utilization in 2024 compared to 83% in 2023.

- 430 units in shelter, compared to 364 units in 2023.
- No change in YoY program count.
- Seasonal beds reduced to 0 in 2024 from 136 in 2023 due to converting Winter Shelter to Yearround









#### Transitional Housing HIC

69% utilization in 2024 compared to 80% in 2023.

- 87 units in transitional housing, compared to 78 units in 2023.
- No change in YoY program count.








#### Rapid Rehousing HIC

HUD reports RRH capacity as 100% utilization.

- 419 units for RRH, compared to 386 units in 2023.
- Programs increased from 19 to 25 YoY.
- Utilization excludes 4 programs with no housing placements on the night of the PIT








#### Supportive Housing HIC

71% utilization in 2024 compared to 77% in 2023.

- 1,872 units in supportive housing (SPC and HCMS), compared to 1,361 units in 2023.
- Programs increased from 35 to 39 YoY.








#### Permanent Housing – Other HIC

100% utilization in 2024 compared to 93% in 2023.

- 66 units in shelter & housing, compared to 80 units in 2023.
- No change in program count
