



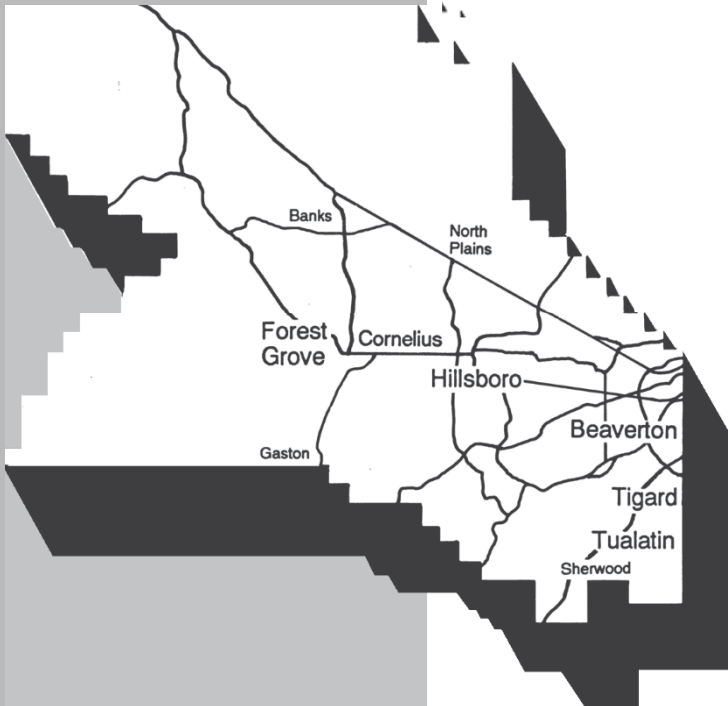

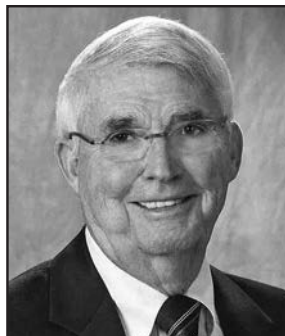

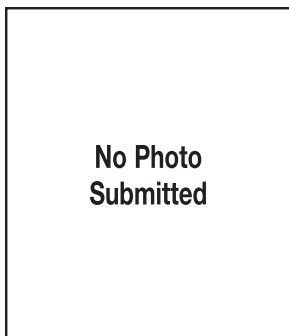

We're all agreed education is a cherished value, and that the ability to read is the core underpinning of that value.

The district paid for my training in explicit phonics in 2004, and I immediately identified it as the most cost-effective method of teaching English. It was FREE after teacher training.

Over the years I've lobbied the board a lot to try phonics. In the last year alone, I've submitted a dozen public comments, offering many resources, such as Dr. Samuel T. Orton, The International Dyslexia Assn, riggsinst.org, Spalding Educational Institute and more. The board does not appear to be interested.

We've made expensive mistakes: \$600K in 2010 for a disastrous Pearson program.

Of course, the pandemic has made everything more complicated.

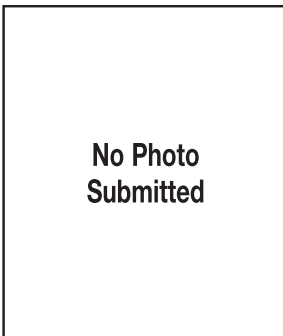

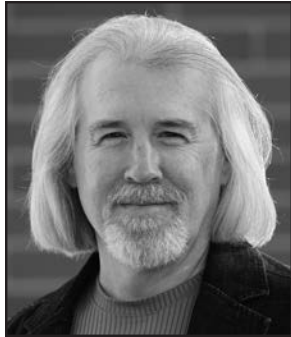

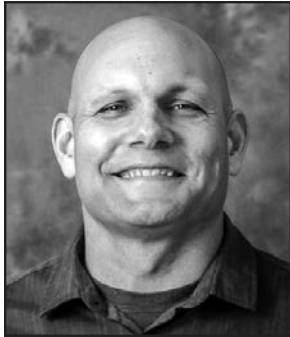

You have the right to vote if you are a US citizen, are a resident of Oregon, are 18 years old and are registered to vote.

You have the right to leave some choices blank on your ballot. The choices you do mark will still count.

You have the right to receive a new ballot if, prior to returning your ballot, you make a mistake.

You have the right to vote if you are in line to return your ballot at any official drop site by 8 PM on Election Day.

You have the right to cast a secret ballot.

You have the right to cast a "provisional ballot" if your name does not appear on the voter roll.

You have the right to choose whether or not to register as a member of a political party.

You have the right to know if your ballot, including a "provisional ballot", was counted.

You have the right to vote if you have been convicted of a felony once you have been released from custody, even if you are on probation or post-prison supervision.

You have the right to file a complaint with the Secretary of State if you think your voting rights have been denied or if you believe any fraudulent activity has occurred.

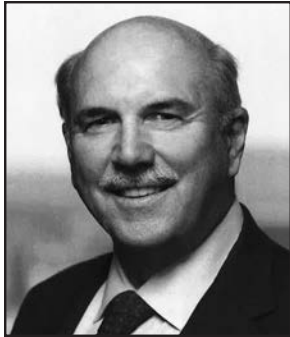

Ballot Title

City Center Urban Renewal Plan Amendment - Requires No New Taxes

Question: Shall the City amend the City Center Urban Renewal Plan, including increasing the amount of Maximum Indebtedness?

Summary: This measure approves an amendment to the City Center (Downtown) Urban Renewal Plan, which would increase the maximum indebtedness of the Plan from \$22 million to \$42.8 million, and duration of the plan by nine years (ending in 2035).

The Plan Amendment would not impose new taxes, nor raise existing taxes.

Funds generated from the Substantial Amendment will support new projects in the City Center (Downtown) area such as:

- Connectivity: Designing and building new streets
- Universal Plaza Phase 2
- Parking Facility
- Tigard Heritage Trail Continuation
- Fanno Creek Trail Improvements
- Housing Development: funds to support affordable housing
- Pedestrian Safety and Streetscape Improvements
- Land Acquisition: buying land to encourage mixed-use development

Funding comes from capturing property taxes from new development and increased property values in the urban renewal area. Funding generated within the area must be spent on projects within that same area.

Urban Renewal is not a new or additional tax.

Explanatory Statement

A **“yes” vote**, would amend the existing City Center Urban Renewal Plan to support public improvements in the downtown area by increasing the maximum amount that can be spent by \$20.8 million and adding nine years to the duration of the Plan.

A **“no” vote**, rejects increasing the maximum amount that can be spent and rejects extending the duration of the existing Plan.

The Plan Amendment would not impose new taxes, raise existing taxes or extend a current tax. Funds generated from the Amendment would be used for new projects within the City Center Urban Renewal Area, such as:

- Designing and building new streets
- Universal Plaza Phase 2
- Parking Facility
- Tigard Heritage Trail Continuation
- Fanno Creek Trail Improvements
- Housing Development: funding affordable housing
- Pedestrian Safety and Streetscape Improvements
- Land Acquisition: buying land for mixed-use development

The existing City Center Urban Renewal Plan was approved by voters in 2006 and has funded nearly 40 infrastructure and improvement projects, including Main Street Green Street, the SW Burnham Street Improvements and Public Parking Lot, the Tigard Heritage Trail/Rotary Plaza and the upcoming Universal Plaza featuring Tigard's first splash pad. Public improvements have attracted almost \$50 million in private investment to

Downtown, including 234 new housing units, new streetscapes and pedestrian amenities, and 28 matching grants to downtown businesses.

About Urban Renewal

When an Urban Renewal Area is formed, existing property tax revenue generated by property within the Area goes to the City of Tigard and other taxing entities as it normally would for the life of the Plan. This is called the “frozen base.” Property tax revenue in excess of the frozen base, which is generated by new development and increased property values in the area, is called “tax increment.” Tax increment financing is used to fund identified projects within the urban renewal area. The total tax increment collected cannot exceed the maximum amount approved by voters.

In the future, property values in Downtown Tigard should exceed what they would have been without implementing the Plan's projects, thereby providing increased revenue to all taxing districts. When the City Center Urban Renewal area expires, property taxes will neither increase nor decrease due to urban renewal.

Implementation of the Plan would continue to be managed by the city's urban renewal agency board, which consists of the members of the City Council. The Town Center Advisory Commission, comprised of volunteer community representatives, will continue to advise the board on public investments. Applications for the board are held every October.
