There is a housing crisis in my community and I want to be part of the solution. Housing is such a fundamental need - and it effects every part of our lives. At the very least, housing stability should be attainable for everyone in my community. I want to work with others to support more funding and more development of affordable housing, including more preservation of affordable housing in our communities throughout the County.

I lived with housing insecurity as young adult, earned a bachelor's degree that focused housing development and US housing policy, and have recent volunteer experience advocating against housing displacement. As a young parent, I often struggled to find and afford housing while juggling work, education and parenting. My housing on the rental market was often neglected but cheap. I was grateful for rent I could afford. While I am no longer housing insecure, I remember how tiring it is to be worried and anxiety about making the rent, and paying bills all the time. My undergraduate degree in Community Development specialized in Housing and Economic Development. It included course work on US Housing Policy and an internship at Community Partners for Affordable Housing (reference: Sheila Greenlaw Fink). I became active with Unite OR in 2018 because of the potential for the SW Corridor Project to cause residential displacement (reference: Cristina Palacius) and am fighting for more preservation resources in this area. I am also learning about affordable home ownership and tools for communal community land trusts while serving on a Proud Ground sponsored project to develop a pipeline of permanently affordable housing along the SW Corridor. My work as land use planner means I am aware of local housing development trends and provides me access to training and professional education related to many aspects of housing development and planning.

Describe your understanding of the concerns and issues facing the Board/s you wish to serve on.

I'm sure there is much for me to learn on this topic. A couple of things I know, we always face resource barriers and the financing of affordable housing is complex. The population the HA serves is facing issues of displacement due to several factors including expiring affordability, a larger group of seniors than ever straining services, and systemic barriers to equitable access across population groups. The HA has a lot of funding and fiscal duties such as state and federal grant program compliance and an agency budget. Transparency on these activities is critical.

List any potential conflict of interest between your public and private service that might result from your appointment to a Board/s you are applying for.

I want to share that Washington County is my employer and not that I do not believe there is actual conflict of interest between my public and private service for the reasons shared below. I do not work for the Housing Authority , however I do for the County in the Department of Land Use and Transportation, for Long Range Planning. My work for the past 2 + years has consisted primarily of amendments to the County's Community Development Code (CDC) of land use regulations that relate to rural land uses. My scope of my work does not include housing policy or housing funding that might affect Housing Authority decision making, nor does it include review or comment on any HA/HWAC project permitting or implementation. There is no overlap in these activities and therefore no potential for a conflict of interest.

Washington County is committed to racial equity and addressing inequities in our programs and services. We lead with race with the recognition that the creation and perpetuation of racial inequities have been built into American culture and our government, and that racial inequities across all indicators for success are deep and pervasive. What experiences, perspectives and values would you bring to support Washington County's equity work through your appointment to this committee/board?

My values are reflected in the Board's recent commitments expressed in the Equity resolution. I want our communities to be just and equitable places for people to live and work, to play and grow in, to learn together. I'm committed to doing equity work in my personal life and in my professional life. Most of my professional development on the topic has focused most on inclusive engagement – which is critical in the planning context – we have to hear from those who will be impacted by the changes we are proposing. Recent workplace training has addressed geospatial inequities in planning policies and reaching more diverse populations. In my personal life, I continue to volunteer with Unite Oregon, advocate at the city level for affordable housing both experiences by my participation in the other experience. In the context of service on the HAC, I'd want to center the voices of those who are the most rent burdened in our communities. I'd also want to center folks who have the hardest time finding housing (I have some ideas about who that is but would want the data to inform us). Those are the perspectives that must inform the PA's work.

The skills we teach and the homes we build meet the needs of the families we serve because the families have input in their building. They also gain valuable skills in maintaining their fiscal security as well as the structure of their homes. I have been on my own personal journey to examine my own preconceptions and root out my own biases. I have always lobbied for making materials that are more outreaching in the programs I have participated in, including OSU Extension Master Gardeners and Food Preservers, CPO #9, Hillsboro Airport Roundtables, Hillsboro 2020 and Hillsboro 2035 and the Hillsboro Food Co-op. As a county, we have done a fair job of outreach and are becoming more adept at equitable outreach. I look forward to enabling more people to expand upon it.
