Project Update: Financial Assessment



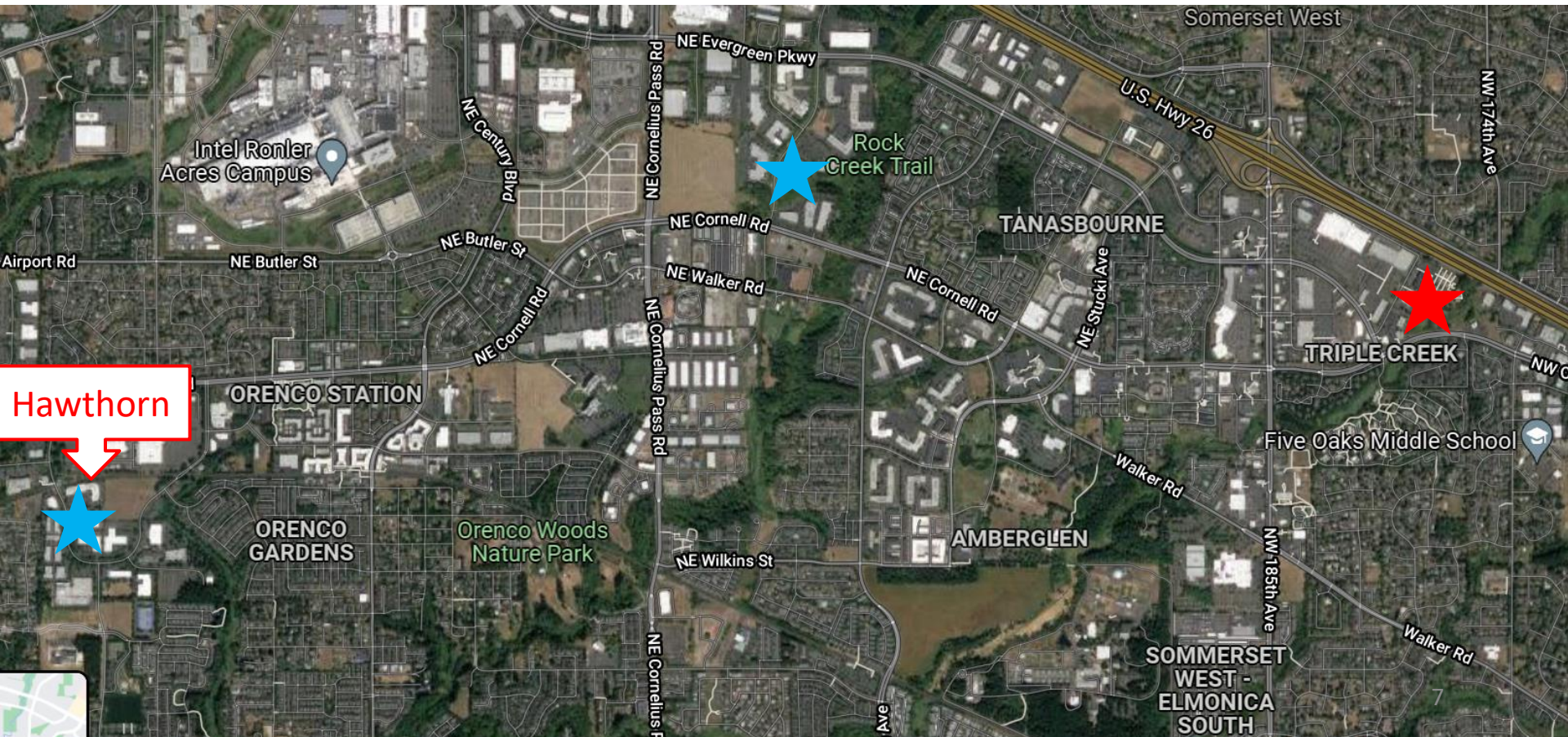
- Three key areas:

- Consultants being hired to inform approach and validate numbers

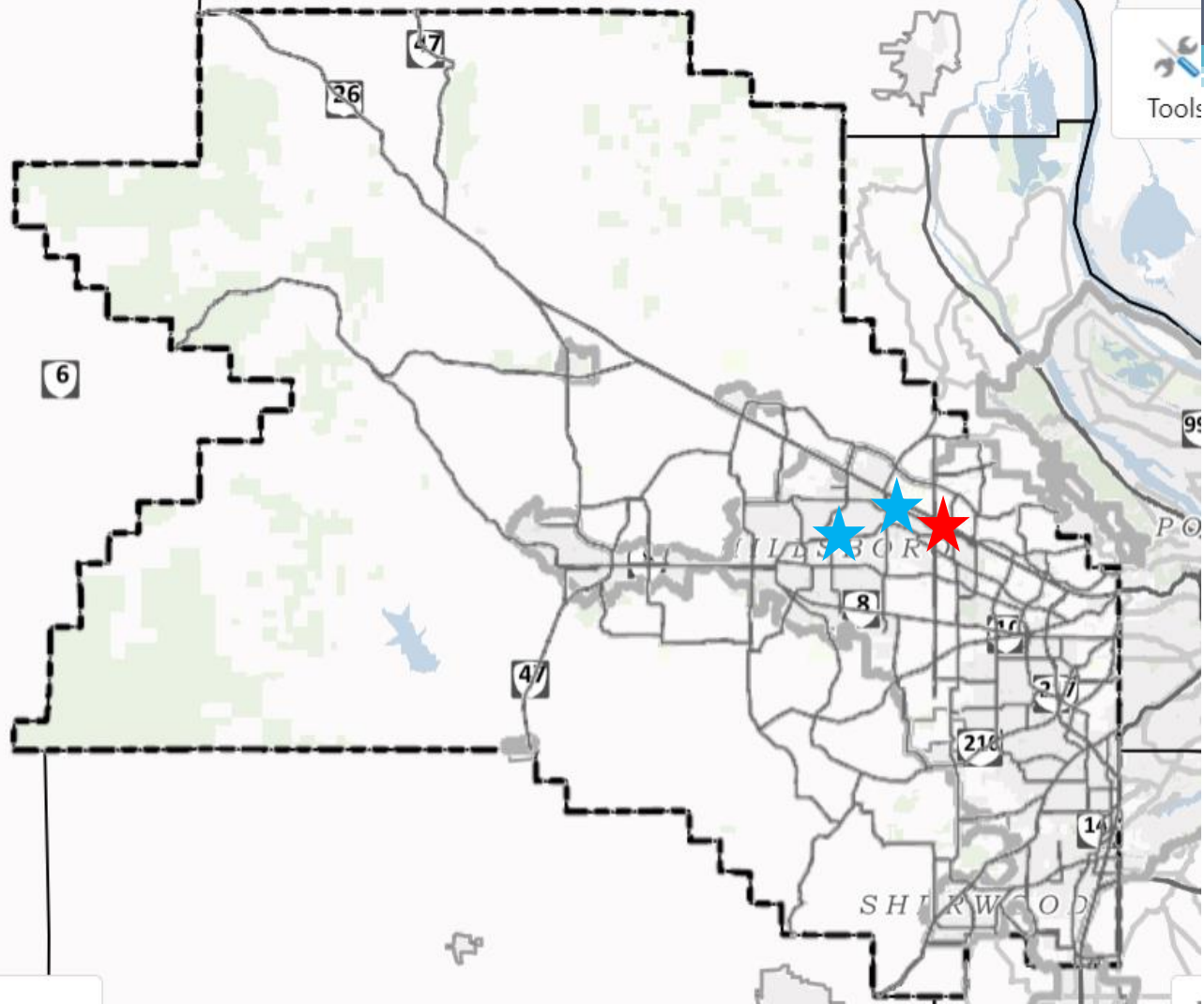
Project Update: Site Selection

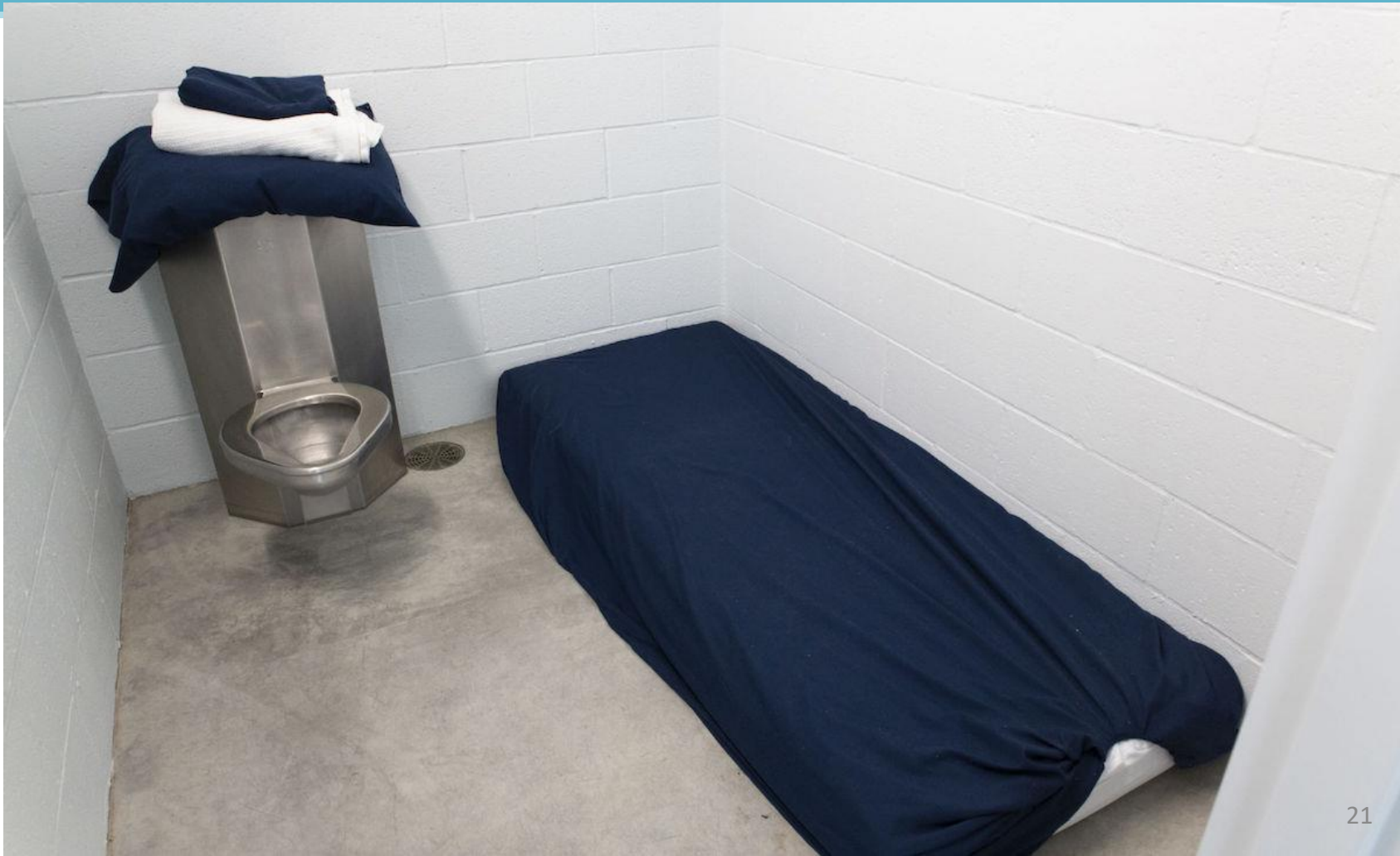
