Call to Order: The meeting was called to order at 9:03 a.m.

Program Updates:

CMHP (Community Mental Health Program):

- Public Guardianship Program- a follow-up was provided with the following information:
 - o This program lives within the Aging and People with Disabilities program
 - o Multnomah is the only county in Oregon with this program
 - There is a statewide public guardianship program, but it is full currently. There is a need for people to provide guardian services.
 - Washington County has historically worked with Gewurtz and Menasche to provide legal consult to family members, but they are no longer doing that. We are working to find another partner.
 - o Guardian Partners may be a new resource available in our county.
- Many Adult Foster Homes (AFH) have been closing including Noble House
 - O Noble House closed on December 31st, but we are working with another provider to see if we can re-open. While it is closed, the Housing department is working on fixing significant plumbing issues in the house (replace the septic system).
 - With the AFH closures, we are working to transition clients from their current locations to new locations in a seamless manner.
 - The main reasons for AFH closures are workforce shortage and increased acuity of clients.
 - While there are some closures, we have also been notified that there are a couple of new Adult Foster Homes opening.
- Hawthorn's hours have changed
 - o They just had a two-week closure due to staffing
- Mental Health Response Team (MHRT) expansion update
 - We have been able to expand to all our cities

- Working on hiring clinicians for the rest of the teams- there is a need for a clinician to work with the Trimet Transit Police
- There have been a lot of success stories from South County teams- lots of good press
- o MHRT is a specialized team with law enforcement official and MH clinician
- Office of Equity, Inclusion, and Community Engagement (OEICE) has been working on a land acknowledgement (which has been adopted by the Board of Commissioners)
 - Based on guidance around use, we will begin using it in February or March meeting

CCO (Coordinated Care Organizations)

- Health Share of Oregon will allocate over 10% of budget to behavioral health (from physical health) over a two-year period
- Received a \$30,000 grant from Trillium to help with an anti-stigma campaign for CATT project
 - Will be working with other CCOs in our area to see if they would like to contribute to the campaign

Addictions

- An update was given about the Measure 110 request for proposal:
 - Our application was submitted (along with 300 other applications)
 - We will find out award identification around the end of February (needed an additional two weeks)

Member Updates

- Carol- The Supportive Housing group has released a roadmap: https://heretogetheroregon.org/wp-content/uploads/2022/01/HereTogether-2022-Roadmap-to-Accelerate-Relief-for-Portland-Regions-Homeless-Crisis-1.pdf
- Lynne- provided an update the Juvenile Department's grant application and how it was success. They will get 4 additional years of funding (which will be geared towards program expansion to include more youth and to enhance services to youth and families of color). Back-to-back grants are very rare, but the Juvenile Department has been very fortunate.
- Marcia- making a request for a Supported Housing update for future meeting
- Sean- language in the New Member Packet regarding Roberts Rules of Order (still in process).
- Sean- regarding workforce issues- are we being creative enough to address the issues?
 - We are looking at rules and doing our best to reduce barriers
 - o This conversation is happening at all levels (including State level)
- There was also a discussion on how peer services are helpful and what is done to reduce barriers (trainings, accreditation, revisiting criteria).
- Working on a process for members so that we can use the member update time as efficiently as possible. If there is an update- please email Aika Fallstrom in advance of the meeting.

BHC Quarter One of 2022 Calendar Review

- January- meeting focus will be tying up loose ends (bylaws, Vice Chair, Mission/Visions/Values)
- February- Forensics updates and legislative session overview and update
