Program Updates:

CMHP:

- Nick Ocon has been hired as the new Behavioral Health Division Manager for Washington County
- There will be busy legislative session- will be a long session this year
 - There have been 3,000 bills and legislative concepts introduced, but we will see which ideas will gain some traction to see which ones we should be tracking
 - There will be some education about some of the bills in the Spring once there is a better idea.

CCO

- Still doing delegated care coordination for Trillium (Wraparound and Choice)
- Trillium has about 10,000 members currently (mostly in Multnomah County)
- Health Share and CareOregon are doing a big push with hospitals to COVID-19 vaccinations to providers
 - Still need help with getting residents vaccinated- supported residential has not been vaccinated yet (congregate care settings).

Addictions

- **CATT (Center for Addictions Treatment and Triage)**
 - Official Feasibility Assessment presentation to the Board in April
 - Feasibility Assessment is over 30 pages and outlines the work that has been done to date for this project
 - Kristin will be giving an update in February to outline the Board before the official Feasibility Assessment Presentation

Member Updates:

- Becky- Children's Advocacy Centers will be asking for an increase of \$3 million dollars during the legislative session

Guest Updates:

- **New Narrative-** will be opening a new residential center in Hillsboro
- **NAMI-** the building is getting a facelift, so there will be a re-opening in the future

Behavioral Health Council Recruitment
