The region is currently seeing an uptick in families entering the family court systems in Washington, Multnomah and Columbia counties which means children and youth in the community need Court Appointed Special Advocates (CASA) to represent their interests. Jazmin Rogue, Volunteer Recruiter for CASA, will present how to volunteer for this special service.

Stephen Roberts, Director of Land Use & Transportation

Mr. Roberts will join us to discuss the force and effect of County Community Plans, Road Standards, and Long Range Transportation plans.
