We have come so far!

As we approach the one year project anniversary since groundbreaking, we would like to acknowledge our Board of County Commissioners, City of Hillsboro officials, County leadership as well as other key stakeholders for taking time to visit the site late August to see firsthand what's happening on the project. We appreciate their insightful comments and vote of confidence with the project team.

As of end of August, we have 63-person crew working on various aspects of the project and so far, chalked up 18,000 person-hours with no injuries. As always, safety is a top priority and we do celebrate the fact the project site has remained safe since groundbreaking.

Additionally, leveraging the design concepts we shared at the June 25th work session and July 16th Board meeting, we have made substantial progress on the signage package for the newly named Wingspan Event and Conference Center. The signage package consists of plaza monument signs for Wingspan Event and Conference Center as well as Westside Commons, corner pylon sign at the intersection of NE Cornell Road and NE 34th Street, and building and parking signs. Key items under consideration include feasibility, size and placement, style, clarity, total signage square footage, unique perceptual identity, orientation cues, memorability and visual character. Equally important, we have engaged our signage sub-contractor to assist with constructability issues.

We are working collaboratively with City of Hillsboro to secure signage permit.

We have come so far!

On the marketing front, we expect to have development of the initial brochures by late September. This is happening concurrently with the Westside Commons website design. Marketing efforts as well as development of collateral materials and the web site for the Wingspan Event and Conference Center are in top gear. The project has generated a lot of interest from our partners, including the Washington County Visitors Association (WCVA) and regional hoteliers. We are working on comprehensive marketing strategies and benchmarks for Board of County Commissioners review in mid-September.

On the construction front, we are wrapping up asphaltting of the North parking lot and plan to reopen access to Westside Commons along NE 34th Street in the near future. The newly completed North lot will serve as a lay down area for the remainder of the project duration to pave way for South lot asphaltting. The first batch of glulams installations for areas A and B is currently underway. Mega trusses are scheduled to arrive by mid-September and joisting activities will commence immediately upon delivery. We expect to receive 15 semi-trailers worth of roofing material by mid-September. The goal is to enclose the building and secure it from weather elements by the end of October.

Last but not least, the project schedule is holding firm due to enthusiastic and participatory team collaboration.

Team Spotlight: Rob Massar Consultant for Washington County
