# **Program Updates:**

# CMHP:

- The liability concerns regarding Aid & Assist have been addressed and the contract (IGA) with the State of Oregon has been signed.
- BHC new member orientation will be in May. Once the date has been set, the information will go out to the current members, if they would also like to attend.
- Ian May has been hired as the new Behavioral Health Program Manager for Washington County.
- Legislative Update- we are still waiting to see which bills come to fruition and will be tracking those on a closer level.

# ССО

- CareOregon and Health Share are partnering with the Public Health Departments of all three counties (Multnomah, Washington, and Clackamas) and hospital systems to get Health Share members vaccinated.
- Beginning in 2019, Washington County partnered with Health Share of Oregon regarding increasing workforce. We just received a report that they have developed a program with Portland Community College to develop Certified Drug and Alcohol Counselors (CADC) in underrepresented communities.
  - In 2019, there was a cohort of 20 people and 87% were able to complete the program
  - In 2020, there was a cohort of 21 people and 95% were able to complete the program

- CATT (Center for Addictions Treatment and Triage) Member and Guest Updates:
  - There is a Beaverton School District Candidate Forum (4/28)
  - There is also an upcoming voter's forum on the City of Beaverton and THPRD
  - New Narrative will be opening their new facility (Pathways House) in Hillsboro
