URBAN* COMMERCIAL SERVICE RATES

Rates effective August 1, 2022

Commercial Container and Can/Cart garbage service INCLUDES recycling of up to two times the volume of the garbage service and food scraps collection at no additional charge.

A 4.00% surcharge will be added to monthly container collection service rates.

For example: An account that has Monday, Wednesday, and Saturday service will be charged an additional 6% on the appropriate 3 times per week collection rate.*

Collection of compacted material: *Containers with compacted materials are charged 2.25 times the loose rate. These rates are based on containers from 1 to 4 yards in size.*

*Urban customers are located within the Metropolitan Service District Boundary.

A \$2.00 surcharge will be added to the monthly can/cart collection service rates.

URBAN* COMMERCIAL FOOD SCRAPS COLLECTION SERVICE RATES

Rates effective August 1, 2022

Commercial Food Scraps Collection Service is only available to Urban customers.*

Cart Commercial Food Scraps Collection Service

Cart Size: 60-65 gallon cart

Collection Frequency: Cart commercial food scraps collection service shall be provided, as requested by the customer, at either 1 or 2 pick-ups per week. Additional pick-ups may be provided at the discretion of the service provider; however, service providers are not required to offer more than 2 pick-ups per week.

Additional collection pick-up frequency, if available, will be charged standard commercial can/cart monthly service rates.

For example: An account that has Monday, Wednesday, and Saturday service will be charged an additional 6% on the appropriate 3 times per week collection rate.*

Collection of compacted material: *Containers with compacted materials are charged 2.25 times the loose rate. These rates are based on containers from 1 to 4 yards in size.*

Rural* Customer Surcharge: *Rural commercial collection rates include a \$2.00 surcharge per pick up for the first container.*

**Rural customers are located outside the Metropolitan Service District Boundary.*

A \$2.00 surcharge will be added to the monthly can/cart collection service rates.

Additional Yard Debris Services and Fees

*Includes every-other-week collection of yard debris using hauler provided 60-gallon carts.
Applies to Urban* customers only. Rural** customers do not receive yard debris collection services*

| Yard Debris-Only Service: Available to all urban customers who <u>do not</u> already subscribe to <i>Standard Residential Can/Cart Collection Service</i> or is an add on service for <i>Standard Commercial Can/Cart Collection Service</i> customers. | \$5.27 |
| Additional Yard Debris Cart: Available to <i>Standard Can/Cart Collection</i> and <i>Yard Debris-Only</i> | \$4.24 |
| Extra Can/Bag/Bundle of Yard Debris: Available to <i>Standard Residential</i> and <i>Yard Debris-Only</i> | \$3.40 |

| Commercial Receptacle Cleaning Fee: Charged per occurrence, per receptacle for cleaning or swap-out based on customer request. Annually, commercial food scraps collection customers receive one free cleaning or swap-out per receptacle. | \$16.00 | \$16.00 |
| Call Backs: Charged when pickup is missed due to customer error. <i>See Administrative Rules Section 14(E)(b)(4).</i> | \$16.03 | \$16.70 |
| Distance Charge: Monthly fee charged to residential can/cart customers when receptacles are placed more than 5 feet from the curbside or the roadside. Haulers shall provide non-curbside or non-roadside residential collection service at no extra charge to disabled residential customers. <i>See Administrative Rules Sections 14N(b)(6)(e) and 14N(c)(5)(e).</i> | 5 feet to 150 feet | \$14.72 \$11.32 |
| | 151 feet or greater | \$22.64 \$19.24 |
| Drop Box/Compactor Service Interference Fee: Charged when the driver is unable to safely service a compactor/drop box because of site issues such as blocked access to the compactor/drop box. | \$35.00 | \$70.00 |
| Drop Box Relocation Fee: Charged when the customer requests that the collection company make a special trip to the site to relocate a drop box on the same site. | \$35.00 | \$70.00 |
| Commercial Compactor Turn-Around Fee: Charged per occurrence when collection requires the driver to turn around the compactor. | \$35.00 | |
| Locked Containers/Doors Fee: Applicable if a commercial customer utilizes locks on the container or enclosure gate that requires that the collection company driver unlock the container or gate. | \$10.00 per lock/per month | |
| Over-Capacity Charge: Fee charged to can/cart customers when the garbage container is overfilled. A good indicator of over-filling is that the lid does not close. | \$2.75 | |
| Unreturned Cart Fee: Applies to residential service only. <i>See Administrative Rules Section 14(F)(j).</i> | \$50.00 | |
| NSF Charge: Charged for non-sufficient funds. | \$30.00 | |
| Reinstatement Fee: Charged after cancellation for non-payment. | \$25.00 | |
| Unscheduled Service: Charged for out-of-the-ordinary service collection of bulky items such as tires or appliances, as well as for requests for other unscheduled services. | \$75.00 per hour plus disposal, if applicable | |
