II. GUEST SPEAKERS:

Andy Cartmill and Juli Pearson, Washington County Health and Human Services "Addiction Services and Care Coordination"

Ms. Pearson provided an overview of the services provided by Washington County Addiction Services focusing on treatment options specifically available through Medicaid and the Oregon Health Plan (OHP). They collaborate with treatment providers, public health departments and schools to remove barriers and provide a coordinated level of care to individuals suffering from Substance Use Disorder (SUD) to reduce emergency room and repeat visits to detox. As the manager of the behavioral health benefit for OHP, they provide authorization for SUD treatment (residential and detox), advocate for individuals in

the community who are seeking services and link individuals to the level of services they need. Mr. Cartmill added, through presentations in the community, Addiction Services educate about substance abuse, suicide and mental health (perception and reality) and inform the public about SUD services and programs available in the county. Specific SUD services available in Washington County through partner agencies, whether through OHP or General Fund contracts (for uninsured) includes Outpatient and Intensive Outpatient. Residential Inpatient, Withdrawal Management (Detox), Medication Assisted Treatment (MAT), Peer Mentor Services, Naloxone (Narcan), Addiction Care Coordination, Prevention, and Education. Looking ahead, additional care coordinators will be added after the first of the year, the possible addition of MAT services to be added in the Criminal Justice System. the possible development of a Drop-in Center in Washington County and through a Public Health Initiative, the possible addition of a van to provide onsite services such as needle exchange and HIV testing. Questions & Answers:

Is the County working with physicians prescribing drugs to educate and inform them?

Tri County Opioid and State of Oregon are working with doctors and dentists in the prescription drug monitoring system. High prescribers are being identified and contacted.

Matthew Mattia, Washington County Office of Community Development "Consolidated Plan"

Mr. Mattia provided a detailed description of the Community Kick Off 2020-2024 Consolidated Plan & Analysis of Impediments, an event scheduled for Thursday, December 13, 2018, 9am-4pm at the City of Hillsboro Auditorium. Washington County's Consolidated Plan is a 5-year housing and community development strategic plan which includes data gathering (quantitative and qualitative) to: 1) Inform how to target federal resources in Washington County, and 2) Through community participation, collaboration and partnerships, identify and analyze impediments to fair housing choice and develop strategies to address them. The outreach required (Citizen Participation Plan) is an essential element in the development of the strategic plan and informs the development of the Needs Assessment and Strategic Plan which in turn, informs the Annual Action Plans for each of the five years of the strategic plan, the results of which are reported to HUD in the Annual Performance Report (CAPER).

The kick-off event will include a panelist discussion from 9am to noon with guest speakers from Housing, Economic Development/Jobs and Homelessness sectors to provide trends and perspectives on strengths, opportunities, weaknesses and threats in each of the categories. A moderator will probe speakers with questions. The afternoon session will include small group discussions in the following categories: Housing, Facilities/Public Services/Micro-Finance, and Infrastructure/Parks. The workshops will examine existing systems for low income county residents (identify strengths, weaknesses, obstacles and potential opportunities of existing systems) and identify strategies for improvement. The Facilities/Public Services/Micro-Finance and Infrastructure/Parks sessions will include development of a non-housing survey for service providers, the results of which will be incorporated in the needs assessment. Who is the initiator of this strategic plan?

It is a collaborative process lead by Washington County Community Development working with Washington County Housing Authority and the cities of Beaverton and Hillsboro.

The current Consolidated Plan, Action Plans and CAPERs will also be available on the website.

IV. GENERAL BUSINESS

John Trinh, William Allen & Lindsay Downen, Luke-Dorf, Inc.

"Transfer of Tom Brewer ownership from LifeWorks NorthWest to Luke-Dorf, Inc." Mr. Trinh provided background information about Luke-Dorf, Inc. who have been operating in Washington County for over forty years. They are a Health Share of Oregon participant, providing housing, clinical and supportive services. Mr. Allen reported on Horizon Property Management, administrators of the housing units owned by Luke-Dorf, Inc. and the highly skilled expertise of the agency to work with vulnerable populations. As a result of the transfer to Luke-Dorf, Inc. it was reported tenants and the property will realize an increase in housing stability of program participants and higher occupancy rates.

Ms. Downen reported Tom Brewer will operate as a Housing First within the eligibility criteria established by HUD regulations for permanent supportive housing and affirmed program participants would not be required to engage in mental health services as a requirement of housing, nor will there be any service disruptions to residents currently receiving services. She noted units at Tom Brewer were available for couples, which was new to Luke-Dorf, Inc. and in high-need across the continuum. The preparation for the transition will include a meet-and-greet onsite with Tom Brewer participants and LifeWorks staff to answer questions and provide re-assurance. Pre-announcements prior to the January 1 transition are planned as well.

Questions and Answers:

Are residents required to have services?

Residents are required to have a diagnosis, but are not required to be engaged in treatment services outside of case management.

For mental health, does it have to be severe and persistent?

They are in the process of evaluating the HUD definition. It has become clear HUD has broadened their definitions for mental illness in terms of authorization and approval.

Are potential residents still required to go through Community Connect?

They are required to go through a Community Connect assessment and Luke-Dorf will also pull from the Section 8 waitlist. Annette clarified all McKinney Vento projects are required to have a Community Connect assessment to determine if the individual needs permanent supportive housing. One of the subsidy components is the project-based Section 8 rent subsidy. The current program eligibility 10.10 reads that they are referred to LifeWorks but

also advised they can apply for the Section 8 subsidy. Everyone who goes through a Community Connect assessment should also be getting a 10.10 that lists all of the open properties at Washington County with project-based Section 8 vouchers.

What is the current occupancy rate?

The current occupancy rate is between 65%-70%.

Are you able to take individuals with SSI (Medicare)?

Yes. That is one of the benefits of working through the HUD definition. Specifically as it effects individuals who are Medicare eligible, but are overfunded for Medicaid.

Amendment to Community Connect Policy.

Annette reported the Community Connect Oversight Committee has determined the Homeless Verification and Self-Declaration form (Appendix 10.6), which was originally put into the Community Connect Policy in 2014 as part of the homeless verification and documentation process, did not serve its original purpose and recommended it be removed. Third party verification (on agency letterhead) to verify homelessness was still required. The Oversight Committee recommended the Community Connect assessment from HMIS be printed to confirm having gone through the coordinated entry system and Appendix 10.6 be replaced with the Consent to Release of Information (ROI) form which was previously adopted but never included in the policy.

Questions and Answers:

Would the Severe Weather Shelter entry form serve as confirmation of going through the Community Connect system?

The entry form is not a Community Connect assessment so couldn't be used to confirm having gone through Community Connect system but could serve as homeless verification.
