# **Homeless Management Information System:** Annette Evans

Annette Evans reviewed System Performance Measures (SPM) that were submitted to HUD. A copy is posted on line and recap sent out via HSSN list serve. Seeing an increase in time those are staying in shelter programs. Also staying flat in regard to recidivism at 11%, goal is 5%. Accolades to HUD funded programs, data clean up occurred specifically regarding annual assessment. We are now at 23% of persons with income for those

programs. There is a lot of work being done. The data entry and quality really needs to express the great work that is being done, which is submitted in APRs to HUD, other reports for various funding streams, pulled annually for PIT, AHAR data is pulled 4 times per year, SPM which is a scoreable factor in the application. This data is also used locally to write 10-year Plan outcomes.

Changes in HMIS staffing to support you all in this role: Duties are split, Jaycanna McVey does basic HMIS training for new users and technical assistance. Annette will be doing the licensing, invoicing, system management and intermediate training so agencies can pull own data to write their own grants. Katherine Galian states there are also requirements in regard to ESG and SHAP requirements that Cecilia Bonvino at Community Action Organization oversees this data entry.

## IV. GENERAL BUSINESS

# **HSSN Governance – Election of Positions:**

In 2006 the HSSN Workgroup was developed which is the Continuum of Care (CoC) Board that provides the administrative oversight of the HSSN, hears grievances if there are issues. To date there have been none which speaks to the collaborative spirit in Washington County. It also holds the HSSN Chair to a level of transparency and ensures that regulatory requirements are being followed.

- HSSN Co-Chair Position: 2-year Term: 7/1/2017 to 6/302019
  - Katherine Galian has several nominations with no other persons nominated
- HSSN Workgroup: 4-Year Terms: 7/1/2017 to 6/30/2021
  - Business: Denise Turner, Denise's Spa Pettie
  - Runaway/Homeless Youth: Andrea Logan-Sanders, Boys & Girls Aid
  - Substance Addiction: Kelley Lesmeister, CODA, Inc.
  - Mainstream Resources: Robin Shultz, Oregon DHS

There is a full slate of nominations for the current vacant positions.

# Nominations open for discussion and motion for approval

Motion: Adopt the nominations as presented.

<u>Vote:</u> Approved, unanimous.

There are also vacant positions opening on the workgroup due to persons leaving. Annette Evans opened the nominations in the following areas for persons representing:

- Experiencing or fleeing domestic violence
- Families with children
- HIV/AIDS

There is no meeting in July and therefore nominations will be open for a month with a closing date for nominations being July 10, 2017.

#### Year 9 Work Plan updates:

This plan was approved by the HSSN on August 3, 2016. The Work Plan is used to inform our elected officials and community stakeholders. Annette will prepare the Year 9 Challenges and Outcomes report using information provided with a draft by September.

# Updates Discussed:

Updates will be taken through the middle of July

- 1. Prevent People from Becoming Homeless: 1.1.c Cities including Tigard, Tualatin, Forest Grove, Beaverton and Hillsboro all contribute to the prevention rent assistance as well as St. Vincent DePaul for those in the Tigard zip code and nonprofits. 1.2: when originally written was meant for staffing through the courthouse due to the rise in eviction court cases which we still see and are losing ground on progress that was made, 225 eviction court cases were made at the courthouse. No activity in this area. 1.3.c: Basic necessities including food, transportation and basic health services as well as referrals for family orientated agencies are given on the day of release. 1.4: more data to be given however, those who are trained outside of community action organization provide the curriculum to participants of their agencies. 1.7: Boys & Girls Aid to provide data on the number of households that have received this service. 1.8.a: will get info from Vera Stoulil at BGA 1.9: Continuing with mortgage payment assistance with Oregon Housing Stabilization Initiative. One program is coming to an end which is the national Foreclosure Mitigation counseling. The Oregon Foreclosure counseling program did not receive any funding. Washington County is still experiencing 50-60 ongoing foreclosures.
- 2. Move people into Housing: 2.1.a Increase rental assistance to serve: chronically homeless, Clover Court has been somewhat delayed. 2.2, 3.4, 4.2, and 5.2: Homeless to work program 10 total beds with only 3 for women. Increase supply of housing units: 2.3 No one present has yet to apply. 2.4 5 units for low income persons 30% AMI, Sunset View meet this through Project Based Vouchers. Annette to get specific data. 2.6 Preserving existing inventory of Affordable and Supportive Housing, city of Beaverton is working on this; Fir Crest Manner is in flux had to be denied for tax exemption, appealed to the state. 2.7 Increase private market housing units, also includes discussion of SDC charges, in process 2.8 Mitigate landlord debt owed by homeless, funding for rent well participant to help incentivize landlords fell through and unsure if it is in a current bill. Annette to collect data
- 3. Link People to Appropriate Services and Remove Barriers: 3.3 Hawthorne Walk-in Center, DAVS office, and Oregon DHS colocation. Annette to investigate on wording to see if this meets this Action Step. 3.7 Preschool Promise is county wide with CAO and others running the programs 3.9 Annette collects and disburses information regarding affordable housing projects where summer meals sites are
- 4. Increase in Income Support and Economic Opportunities: 4.2.b LWNW and SMH both have employment programs. HomePlate also has the YEP program and Bridges to change has an employment mentor program. 4.3 non Profit Brokerages offer help many times a year with training in regard to reporting training, saving money, etc. SSA provided training in May as they committed to providing two meetings annually to help service providers help their clients apply for SSI. Also need date for Soar training. 4.5 HomePlate is a partner and Annette to collect more data. 4.6 Bridges to change has a mentorship program for employment.
- 5. Expand Data Collection: 5.1 Annette to collect data on the increase of HMIS users. 5.2 SPM was submitted on 6/30/2017. 5.3 Annette to look back at minutes for this data and also done at the HPAC (Homeless Planning Advisory Committee). 5.5 Complete and all data submitted.
- 6. Implement Public Education on Homelessness 6.1 Website, Presentation, and Media Emily Starbuck presented on Employment in Washington County: one third of jobs cannot support rent for a one bedroom apartment. 6.3 Forest Grove and Tigard have had community meetings on homelessness and Cornelius had a meeting last August. Just compassion is also taking the lead on having discussion with the community in this regard as well as Washington County Thrives.

Please note that the community is encouraged to mention possible gaps in services in initiative to be added to the 10-Year work plan. What happens at year 10? Will take a look at what other CoCs are doing, bring back to the HSSN and discuss during the HSSN Workgroup to come up with initiatives and plans, as needed, to address barriers and gaps and will go through the formal adoption process with the County Commissioners.
