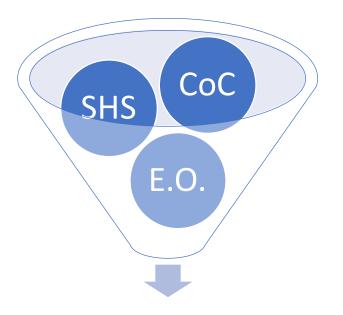

State of our System

Supportive Housing Services Approach to ending homelessness through providing stable housing for all, transparent oversight, accountability and leveraging existing resources

Governor's Executive Orders Utilizing an ALL IN, three pronged approach to create new structures and increase coordination between state and local governments in response to the growing unsheltered crisis

Continuum of Care *Community-wide commitment to the goal of ending homelessness. Comprised of government, non-profit and community leaders who coordinate utilization and access to mainstream programs*



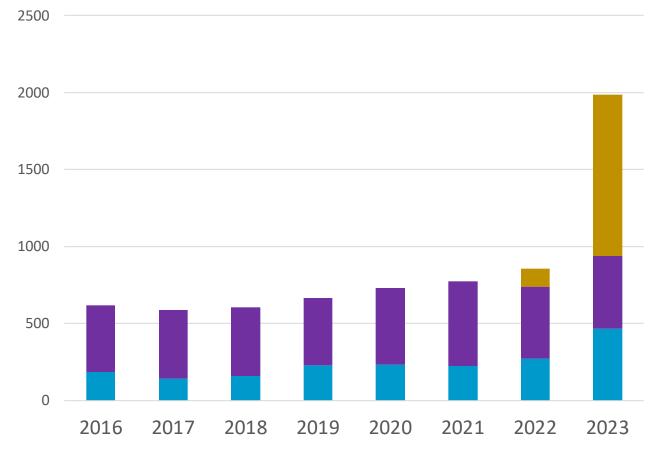

FY 22/23 Successes (so far!)

Housed 1000 people in Supportive Housing!

Double housing program capacity to support 2000 households at once

70% of the people housed in our programs were either unsheltered or in a shelter

Launched new programs

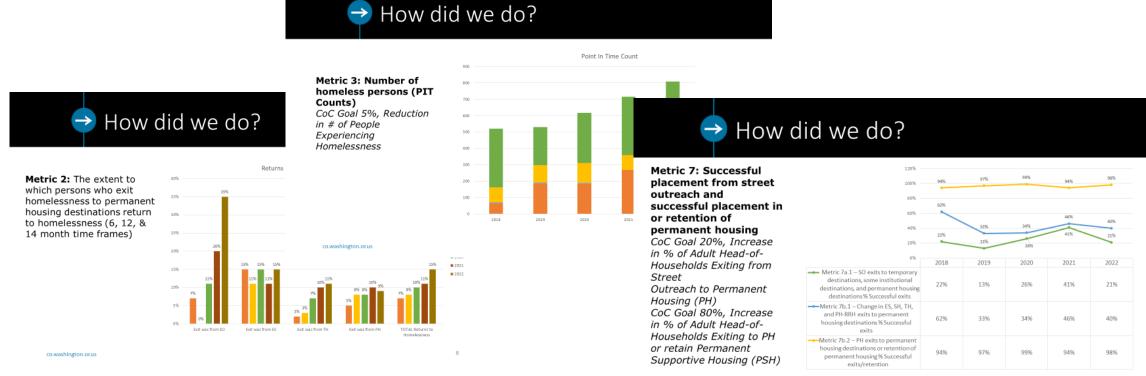
- Dramatically expanded Rapid Rehousing with SHS funding

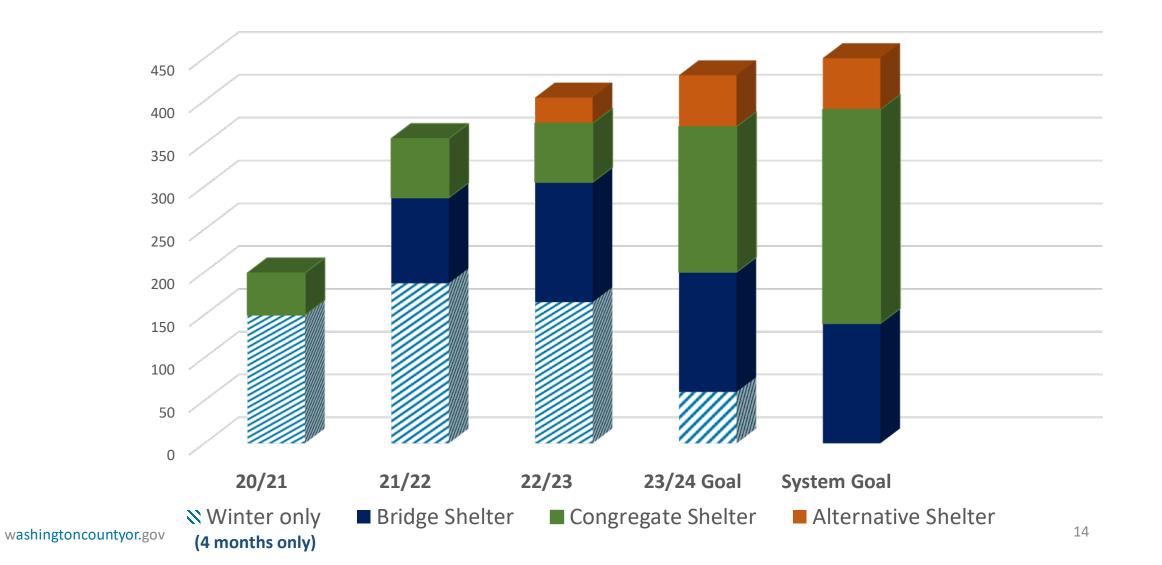

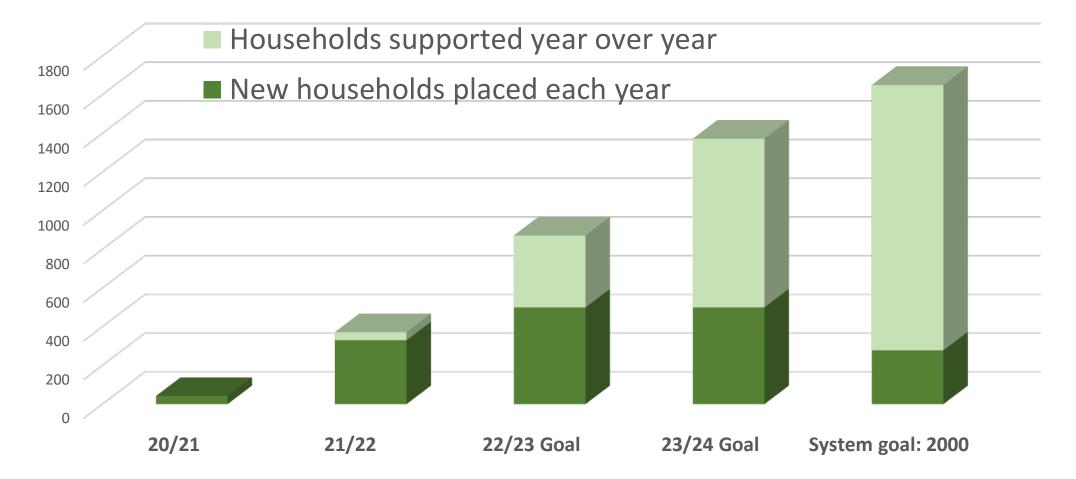

Draft Goals: Advance Racial Equity

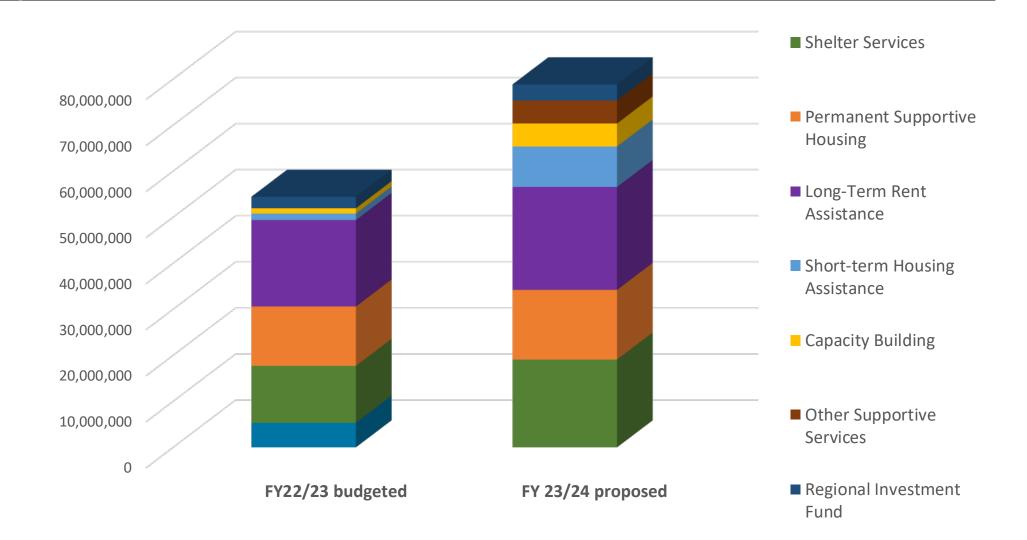
- Address and resolve racial disparities for Asian American/ Pacific Islanders in housing program outcomes
- Expand Diversity Equity and Inclusion training competencies and ensure 100% participation across system of providers
- Expand contracting opportunities and increase technical assistance supports for culturally specific providers
- Others?



Draft Goals: Improve System Performance

- Provide capacity building grants to 75% of organizational partners (17) before end of fiscal year
- Average days in shelter are no more than 100 days
- Launch new programs
 - Recuperative Care shelter and Youth focused housing programs
 - Evaluation and monitoring program to ensure contract outcomes and impact
 - One aligned governance structure to oversee and advise on homeless service system
- Others system improvements?

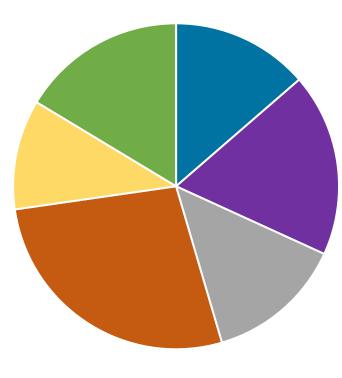

Funding to Achieve Goals

One-time and carry-over funding: \$55 + million



- Program reserves: \$7.5 M
- Shelter Capital Fund: \$10 M +
- Access Center Capital Fund: \$7.5 M
- PSH Acquisitions: \$15 M
- Eviction Prevention: \$6 M
- Governor's E.O. \$8-10 M
