Washington County Department of Housing Services (DHS) requests \$249,191 to fund .5 FTE Homeless Program Manager, .5 FTE Program Specialist, and .5 FTE Program Coordinator to:

1. Coordinate inclusive CoC governance activities and public planning meetings, implementation work supporting local and federal strategic plans, discharge and disaster preparedness planning, perform administrative oversight of the coordinated entry system “Community Connect”, develop criteria for project review and selection, complete the CoC Program grant application;
2. Monitor project and system performance, enforce compliance to CoC and ESG program regulations, Housing First, HMIS implementation; and
3. Implement and monitor CoC written policies and CoC Program Administrative Plan to ensure compliance with Violence Against Women Act (VAWA), fair housing, and anti-discrimination.

Upon funding award, planning will commence to:

1. Coordinate planning activities to prepare monthly CoC meeting agendas, minutes, planning calendar, and annual work plan that supports the implementation of priorities outlined in the CoC local homeless plan within month 1. Perform outreach to invite community stakeholders to attend CoC planning meetings and participate in HMIS data collection. Plan and provide oversight for bi-annual point-in-time (PIT) and annual housing inventory count (HIC), conduct housing and service gap analysis annually comparing HIC and Coordinated Entry data, and participate in the Consolidated Plan process. Manage Coordinated Entry oversight. Operate collaborative process to develop CoC Program applications and funding submissions.

2. Perform monitoring of recipient/subrecipient performance, evaluate compliance and corrective action. Develop and implement project and system performance evaluation criteria that focuses on reducing the length of homelessness and returns to homelessness; evaluate the effectiveness of programs in providing equitable access for homeless populations through outreach and engagement; evaluate income growth of program participants; and the CoCs success in reducing the number of people who become homeless. In partnership with Office of Community Development, perform consultation with local and State Emergency Solution Grant (ESG) recipients to evaluate and report on performance of CoC Program and ESG projects.

3. Review and update CoC Administrative Plan and all CoC policies to ensure compliance with federal regulations. The CoC will address racial disparity and monitor the CoC Administrative Plan to ensure compliance to Affirmatively Furthering Fair Housing, Program Accessibility and Section 504 compliance; and other policies adopted by the CoC that provide homeless persons with housing and services; program and payment standards; HMIS data sharing in support of coordinated entry, and monitor compliance to VAWA.

At the time of contract execution, the Homeless Program Manager (HPM) will convene CoC stakeholders to address resource gaps and modernize the system. Timeline for implementation includes coordination and publication of written agenda, meeting minutes and planning documents posted on the CoC website and provided to CoC stakeholders:

- 1. Coordination of CoC planning activities – Month 1, monthly to completion
- 2. Project and System Monitoring and Evaluation – Month 2, monthly to completion
- 3. Policies and Procedures for HUD Compliance – Month 3, monthly to completion

The CoC stakeholders and CoC Board will participate in subsequent planning activities to accomplish the goals identified. Project timelines including target dates for completion will be established and progress regularly reported to the CoC and CoC Board to ensure transparency and accountability.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

HUD funds will be used to leverage additional capacity to effectively monitor the need for homeless services and align efforts to respond to and meet identified needs through comprehensive planning activities by the CoC. The grant will improve the CoC's ability to operate within a collaborative governance process, monitor and evaluate the outcomes of CoC and ESG projects using standardized and transparent evaluation criteria, coordinate and submit the CoC Consolidated Application, develop and monitor a CoC system that complies with Fair Housing to include Equal Access Act and anti-discrimination, and establish policies based on CoC and ESG standards that create consistency and support across the CoC network of providers and consumers.
