A. Elections - 2023 HAC President and Vice President

B. Approve Recommendation of the Metro Bond 2022 NOFA for Approval from the Washington County Board of Commissioners

Washington County identified a remaining balance of \$13 million of Metro bond funds, and on August 26, 2022, released a NOFA for these funds. Applications under this NOFA were due October 21, 2022, and five applications were received. Staff conducted an initial review to ensure that applications were complete and complied with the framework requirements and application instructions.

A Review Committee was convened with four members who were volunteers or Washington County staff with expertise in affordable housing. The Committee reviewed the application materials, the consultant reports prepared by High Impact Financial (engaged to evaluate project feasibility and financial characteristics) and conducted a meeting to discuss questions and share perceptions about the applications. The Review Committee members then individually rated the applications and provided comments regarding their scoring. Staff tabulated the Committee scores to produce an average score for each application.

Staff will present the results of the scoring and project evaluation at the HAC Meeting. Washington County staff will also discuss a proposal for how the Metro Housing Bond NOFA funding could be aligned with available Metro Supportive Housing Services capital funding opportunities to help support proposed Permanent Supportive Housing (PSH) units.

V. NEW BUSINESS

A. 2023/2024 Housing Services Department Budget Planning

The Washington County Department of Housing Services (DHS) commits to the principles of diversity, equity and inclusion for all members of the community we serve. The intent of this discussion is to gather community feedback that will inform the work of DHS and partners to sustain and build housing services in Washington County over the next year. Three questions to consider in our discussion: (1) What solutions to address housing and homelessness are most important to you and the community you serve?
