I. INTRODUCTIONS

II. GUEST SPEAKERS:

John Wheeler, Washington County Emergency Management Cooperative (EMC) "Shelter Response Planning for Disasters"

John provided an overview of the Disaster Shelter Project being developed by the EMC for emergency shelter during a major disaster before national sheltering resources arrive. Local governments, community and faith-based organizations, and other stakeholders will need to be involved in the plan's development process as they will be the mechanisms by which emergency shelters are organized and activated. Things to consider in the plan's development include mass care services (food/water), equity, care for people with disabilities and those with other access and functional needs, medical care, human and animal services and interagency coordination. The first phase of the plan is the development of a disaster shelter framework to include the creation of an emergency sheltering partnership, establish leadership, organizing resources, identify sheltering needs and planning assumptions and gain agreement on sheltering strategies for personnel, facilities, training, and shelter operations. Community agencies/partners will be encouraged to attend a series of workshops to develop the disaster shelter framework. Questions & Answers:

Gordon Teifel shared Boy Scouts of America was already encouraging disaster preparedness by offering a merit badge, called "Emergency Preparedness." Also, Families for Independent Living have been working with adults with developmental disabilities, helping them to be less anxious about disaster preparedness.

Does this plan include rural areas? Are shelters expected to be concentrated around hospitals?

Phase 1 of the project will involve an analysis of the most effective distribution of shelters countywide. Social vulnerability issues will be taken into account.

Is there capacity for pre-disaster evaluation, going into businesses to evaluate potential hazards?

There is not currently an organization providing that kind of service; however, risk mitigation analysis is being performed within organizations as well as resources being made available for organizations to perform self-analysis.

Melanie Adrian, Alicia Lindsay, Parishad Malek, OneApp

"OneApp Oregon Program – Developing Partnerships to Reduce Homelessness" Melanie provided an overview of OneApp which is an online housing platform for renters with a mission to connect pre-gualified renters to housing through a transparent rental process. The program reduces length of time spent by applicants looking for rental housing when unaware of property qualifications and the increased expense incurred when submitting multiple applications as a result. Applicants looking for rental housing create an account on the website and complete a renter profile which includes a background check that is used to prepare a rental screening. The applicant forwards their application to the housing of their choice along with a one-time \$35 fee. If they need to re-send their application to another property, no additional fees are required. Alicia Lindsey added they are currently working on an affordable housing pilot with REACH CDC and Epic Property Management in Bend and solicited other affordable housing providers interested in participating in the pilot to contact her as she had room for two more. She also announced the unveiling of their wait-list purge system in April 2019, which automatically purges a housing program's wait list. OneApp 2.0 is expected to be launched sometime next year and will include a Renter Marketplace of companies and services available in their area as well as a toolbox for products and services that might help renters in their unique situation. Predatory companies will be prohibited on the site. The OneApp Guarantee is another product they will be adding where for a fee. OneApp will provide a guarantee for the individual for a period of 6 months, acting essentially as a co-signer for the renter. Questions & Answers:

How long did the process take for the person in the video to obtain housing? The OneApp application process is instantaneous, so in their situation, it took them 3 days to move from homelessness to housing.

Can people search for properties without creating an account?

Yes, the only time an account is required is when you want to send an application to a housing provider.

Does the applicant have to have an email address and phone number to create an account? Yes, they do have to have an email address, but OneApp is working on the ability to set up the account with the case worker's email address to act as a liaison.

Would property managers be able to see the case worker's email address linked to the account?

Yes, there will be added functionality that will give the case worker authorization by the applicant to provide information to the housing provider.

How long does it take for the screening to be completed?

The rental verification is the piece that may delay the process. The rest of the screening is instantaneous.

Have you been successful in partnering with affordable housing properties? At this point, they can only support properties with tax credits. Currently they include REACH portfolios, but not HOME or HUD units yet.

Is there a timeline for when you might be supporting HOME or HUD units and will you be reaching out to the Housing Authority at that time?

Yes, they are working with Housing Authorities across the state and across the country. *What is the business model?*

Currently the one-time \$35 fee is the only source of income generation; however, future product offerings are expected to grow the revenue stream.

How long do renters (with barriers) have to resolve issues on the initial application without having to pay an additional fee?

Renters have 90 days within which to resolve any rental issues that disqualified them on the original application. Portland Community Reinvestment Initiatives, Inc. (PCRI) are looking at using OneApp to vet their wait list and show renters what they need to be working on. *Do you foresee incorporating a housing rating system in the program?*

At this point, they have no plans of including a rating system.

Megan Cohen, City of Beaverton

"Safe Parking Pilot Program"

Megan provided an overview of the program which aims to provide a safe and legal place for those experiencing homelessness and living out of their vehicles to park. It was developed as just one of the responses to Beaverton's rising housing crisis, the increase in homelessness and to provide a legal option for people affected by the ordinance passed in Beaverton that prohibits overnight camping/parking. They are looking for partner participation in the pilot program in two areas: (1) Centralized management of sites and case management, and (2) hosting a site. She provided documents detailing the scope of services for a non-profit Program Manager and the requirements for hosting a site. A Request For Proposal (RFP) for a non-profit program manager partner was expected to be issued within the next two weeks. The program hopes to have five (5) host sites, one of which will be provided by the City, and are looking for partners to host the additional sites. Questions & Answers:

What is this program expected to cost the City of Beaverton?

The program is a pilot with a one year duration and is anticipated to costs \$40,000 (\$30,000 for program management and oversight and \$10,000 for the host sites and services provided). Staffing costs are included in the program management costs.

Metro "Trash Bag Collection" pilot project.

Annette reported the project provides a garbage disposal option for homeless in Washington, Clackamas and Multnomah counties. Bags (with Metro's pick up phone number printed on it) are distributed to homeless and picked up at the homeless campsite or a participating agency's site. Each bag will be weighed and the data tracked to determine how much waste was collected to improve the public health.. Currently bags are being distributed at severe weather shelters and day centers.
