## Point in Time Count




### What is the Point in Time Count?


#### The Point in Time Count (PIT) is an annual HUD required count of homeless individuals in our community:

- Is a snapshot as of 1/23/2025
- HUD Requires a Shelter count every year and Street count every 2 years
- Street Count conducted this year was regional and project managed by PSU
  - Both our Shelter and Street Count data was deduplicated at a regional level
- Notes about the Street Count:
  - Volunteers collect survey information, but participation in the survey is voluntary and often we have incomplete information
  - We attempt to match each person in the Street Count with an HMIS record to ensure de-duplication with our Shelter count
- Point in Time Count is used nationally to understand and compare homelessness across the nation and included in reports to Congress that could impact Federal spending on homelessness


### Homelessness is Rising in our County




## This is Consistent with the First Time Homeless Metric on our SPMs

## What is the Housing Inventory Chart?


The Housing Inventory Chart (HIC) is a HUD report that captures a point in time snapshot of the capacity and utilization of all shelter and housing programs serving homeless individuals in our CoC as of the night of the Point in Time (PIT) count:

- The HIC does not include Prevention, Coordinated Entry, Street Outreach, or other Services Only programs
- Utilization for Housing Programs is based on the households housed on the night of the PIT and does not include those enrolled but not yet housed
- HUD requires that all RRH units and beds are calculated based on those housed on the night of the PIT, always resulting in 100% utilization

## Overview of Housing Inventory

#### Housing Inventory Chart (HIC) as of 1/23/2025


- Utilization increased to 90% in 2025, compared to 77% in 2024
- 3,234 shelter & housing units in 2025, up from 2,844 in 2024
- Program count grew steadily from 76 (2023) to 86 (2024) to 87 (2025)




## **Emergency Shelter HIC**

#### 78% utilization in 2025, down from 84% in 2024

- Shelter units declined from 430 in 2024 to 370 in 2025
- Programs decreased from 17 to 14
- Majority of 2025 beds (56%) served households with children







## Rapid Rehousing HIC

#### RRH is always 100% utilization per HUD Guidelines

- 598 RRH units in 2025, compared to 389 in 2024
- Programs increased from 25 (2024) to 30 (2025)
- 58% of beds were occupied by households with children







YoY Units

### Supportive Housing HIC

#### 88% utilization in 2025 compared to 71% in 2024

- 2,018 units in supportive housing (HCMS & SPC) in 2025, compared to 1,872 in 2024.
- Programs steady with 38 in 2025, vs. 39 in 2024
- Beds were prominently utilized by households w/o children (71%)





## Acronyms

Acronym	Full Name	Description
PIT	Point in Time Count	Annual snapshot count of homelessness in our County, always occurring on a single night in the last 10 days of January.
HIC	Housing Inventory Chart	Annual report of system capacity and utilization
HUD	Housing & Urban Development	Federal department responsible for Homeless Services
SHS	Supportive Housing Services	The Metro bond that was passed in May 2020 that funds the majority of our homeless services.
HMIS	Homeless Management Information System	Database where all our homeless services
СН	Chronically Homeless	People meeting the HUD definition of chronic homeless. These are people with a disability who have been homeless for over 1 year or meet other long-term risk factors
