II. GUEST SPEAKERS:

Allie Martin and Esther Nelson, Safety Compass "Human Trafficking in Washington County"

Ms. Martin provided an overview of Safety Compass, a confidential non-profit agency working in collaboration with law enforcement and social service providers to provide support for survivors (to age 25) of commercial sexual exploitation (CSE) and sex-trafficking in Washington, Clackamas and Marion Counties. In-person advocacy services they provide include navigation through the criminal and social justice systems and court accompaniment; 24/7 emergency response to scene at law enforcement facilities, juvenile intake centers, emergency rooms and child welfare requests; case management and resource referral to service providers. They also provide on-line support for families of missing and chronically exploited youth and adults. A Diversion Program was developed in Clackamas and Marion Counties for adult survivors of CSE (18 – 25 years) facing Prostitution charges which views offenders as victims of the industry and provides a 8-10 week curriculum working through a Community Court. Upon completion of the program, charges are dropped. Safety Compass advocates assist victims throughout the diversion

process, providing support and court accompaniment. The Oregon Department of Justice provides funding for seven (7) county taskforces which focus on human trafficking. Safety Compass has an advocate in each of the three counties they work in who is assigned to "Coordinator" positions within each respective taskforce. Allie Martin is the Coordinator of the Washington County Human Trafficking Taskforce (WCHTT). In Washington County, the WCHTT is working with the District Attorney's office to modify the view of offenders charged with the crime of Prostitution as "victims" and to determine the best method to work those cases within that framework. Safety Compass believes public education increases awareness and results in increased victim identification and better intervention outcomes and offers specialized training for first responders and social service providers in identifying and appropriately serving survivors of CSE. Ms. Martin provided a review of who was being exploited, noting a nationwide average age of victims to be 13 and an Oregon statewide average age of 16 and almost always having experienced prior child sexual abuse. Runaway, homeless and displaced youth were particularly at risk, statistically experiencing sexual exploitation by the time of their fourth runaway episode. As a result, the WCHTT focusses much of their effort in early intervention, working with service provider agencies and the Juvenile Department to identify number of "runs" and other red flags to identify vulnerable individuals. She reviewed the different recruitment methods employed by the industry and the reality experienced by victims/survivors, and shared red flags to identify potential victims/survivors. Esther Nelson offered a "deeper dive" training to agencies to better understand the industry and ultimately better serve potentially vulnerable populations. She encouraged agencies to contact them if they suspect a client might be involved in the industry regardless whether the suspicion was confirmed or not. Questions & Answers:

Upon sending a referral to an agency, how long do you stay connected? If the individual signs a Release of Information (ROI), case management continues indefinitely in collaboration with the agency. If not, they remain in the background providing case management within the confines of confidentiality.

Is the Diversion Program only available to individuals going through the court? The program is for adults being charged with Prostitution in Clackamas and Marion Counties. Minors are usually not charged with Prostitution, although there are counties where that is not the case.

What is the point of contact? Is it just through the criminal justice system, or are your advocates doing street outreach as well?

The majority of referrals come through the criminal justice system, although they receive self-referrals and referrals by victims/survivors with whom they are already working. They do not endorse "venues" as a safe and viable street outreach option for survivors, considering them a "point of sale" and a location where survivors are more vulnerable.

Would you take referrals from service provider agencies or homeless outreach staff? Upon receiving the referral, they would collaborate with the referring agency on a confidential basis until an ROI is signed by the survivor.

Should an agency call the referral line if they suspect a client is involved in the sex industry, even if they are working independently?

Yes; however, keep in mind that Safety Compass only works with individuals up to age 25. There is a different dynamic at play and other organizations to whom sex workers involved in the life and older than age 25 are referred.

What similar services are available in Multnomah County?

Multnomah County was the flagship program for human trafficking, but has experienced a shake-up over the past year, but are in a re-building phase. She suggested referrals to a

Multnomah County program should go to Call to Safety, (888) 235-5333 with a request to be referred to the New Day Program.

Is there a program in Washington County for referring clients older than 25?

The dynamics of the industry make it difficult to identify a clear resource to refer survivors who have aged out of the market. Most often; basic needs (housing, detox, domestic violence) are the priority prior to working through any trauma or mental health issues. Safety Compass will be located on-site at the Family Justice Center and are working through legal to make that happen. They also work with Washington County Mental Health and LifeWorks.

Is there specific training that you offer to agencies?

Safety Compass is mandated to provide training. Contact Allie Martin directly and include information specific to the clients and the environment the agency works within.

Patrick Rogers, Community Action Organization "2019 Point-In-Time (PIT) Homeless Count"

Mr. Rogers provided a brief history of his involvement with the annual homeless count, noting this year would mark year 19. The annual homeless count process continues to change and improve from year to year. This year, in particular, homelessness is receiving much attention and visibility resulting in increased volunteer participation and improved organization and efficiency. Counts in Washington County are scheduled for January 23, 28 and 29 with Hillsboro, Forest Grove, Beaverton and Tigard all scheduled for the same day (January 23), which should greatly reduce duplication. He demonstrated the on-line volunteer sign-up page which allowed volunteers to sign up for an initial training offered in multiple locations, dates and times (Beaverton City Library, Hillsboro Civic Center and Tigard City Hall) and then indicate the volunteer city of preference. Each municipality had a point Lead who successfully rallied city workers and staff to participate. To date, 45 volunteers had signed up. He encouraged anyone interested to access www.caowash.org and follow the links to register for the volunteer training.

Gordon Teifel shared the importance of having a short, succinct but memorable message to describe your non-profit. Daytime Enrichment Activities and Recreation (DEAR) recently received a donation of \$3,000 from WinCo Foods' Golf Charities Foundation because a staff member remembered their message from three years ago as they were deciding where to send excess corporate grants. He also introduced Dan Peccia of Self Determination Resources Inc. (SDRI) who provided DEAR early funding when they first started out ten years ago. SDRI provides case management services to 635 developmentally disabled individuals,18+ years and living independently/with family in Washington County.

Mental Health & Special Needs Community Consortium Steering Committee: Annette Evans Annette evans@co.washington.or.us

Given the change with the CHA as reported earlier and the work done to develop the next phase of the homeless program, *A Road Home*, it has become apparent the foundation for delivering mental health services and special needs is housing, whether independent or facility-based housing. Annette recommended combining the Permanent Housing Subcommittee and Mental Health and Special Needs Community Consortium subcommittees and expand participation to the Housing Authority, non-profit housing developers and service providers. She asked for feedback from the membership and received confirmation that it was the logical thing to do. She will move forward to convene a combined subcommittee and will send announcements via the HSSN ListServ as meeting dates were scheduled. She added she would use the sign-in lists from *A Road Home* in her notices to include those individuals who attended those meetings but who were not able to attend the HSSN meetings.

Gary Smith reported they met in December and continued discussion on the By-Name List, VASH and improving Salvation Army's HMIS data entry. - Matt Mattia announced the Community Development Non-Housing Needs Assessment Questionnaires are due Friday, January 25. He reminded agencies they may be disqualified from applying for CDBG funds during 2020-2024 without participation. He also announced he had accepted a position with Business Oregon and January 17 would be his last day with the Office of Community Development. Annette commended his work on both the HSSN and the HSSN Workgroup.
- Juri Hobbs of The Portland Rescue Mission announced their men's and women's
 residential programs have never been at capacity in every season they have been open
 and had never received referrals from Washington County. By attending the HSSN
 meetings, he hopes to establish relationships that will encourage referrals to their

- Sarah Weller of Write Around Portland announced they will be finalizing their Spring 2019 Creative Writing Workshop schedule and encouraged agencies to contact her to schedule a creative writing workshops for their clients. Participant work is published in an anthology and presented in a public reading. She would like to see more representative work from Washington County. The Spring 2019 anthology is especially important as it marks their 20th Anniversary year.
- Annie Heart of Family Promise of Washington County invited the membership to their annual fundraising gala on February 15 noting they will be looking for sponsors.
