## Draft email to organizational staff Hello,

Metro's Housing Department is excited to provide an update on their training work and recruit for an engagement opportunity they need the support of frontline providers on that is quickly approaching, and to request feedback on programming that is being developed.

Metro's housing department is reaching out today to:

- Update you on the training work that we are currently involved in and get your feed on training programming that's being developed in collaboration with Portland Community College,
- Alert you to some immediate training opportunities/resources that Metro has stood up, and
- Invite you to apply to a limited-duration workgroup that will help to ensure that the programming through PCC meets the unique needs of the region's providers.

As mentioned above, Metro is currently partnering with Portland Community College to develop two courses for front-line housing service workers to ensure they have the tools they need to succeed early in their careers. The courses are Basics of Housing System Navigation and Housing Service Worker Case Management and Metro is hopeful that the first cohort for both courses will enroll in late spring/early summer 2026. These courses will require no pre-requisite education to enroll in and are currently being planned to be non-credit courses (meaning attendees will not get college credit for attending, though there may be future opportunities to create non-credit certifications from the course).

Metro is currently in the curriculum development process and **plans to stand up a workgroup comprised of providers from the region** to get feedback on what is being developed.

## The asks

It is very important to Metro to get feedback from the people actually doing the work on the programming that we are developing. To help ensure this, Metro is hosting several engagement opportunities that they are hoping you will consider giving some time to:

Ask #1: Metro Housing Fall 2025 Front-Line Service Worker Survey: This survey should take 20 minutes to complete and will gather your feedback on several areas relating to the training and technical assistance work that Metro is spearheading. Your input will be used to help develop current programming and identify future training needs/initiatives.

Ask #2: PCC Curriculum Development Workgroup Survey: The survey is being circulated to recruit for the limited-duration PCC Curriculum Development Workgroup, which will likely meet monthly between November 2025 through April 2026.
