Implement and monitor CoC written policies and CoC Program Administrative Plan to ensure compliance with Violence Against Women Act (VAWA), fair housing, and anti-discrimination.

Upon funding award, planning will commence to:

- 1. Coordinate planning activities to prepare monthly CoC meeting agendas, minutes, planning calendar, and annual Work Plan that supports the implementation of priorities outlined in A Road Home, the CoC local homeless plan aligned with the Consolidated Plan and Home Together: Federal Strategic Plan within month 1. Perform outreach to invite community stakeholders to attend CoC planning meetings and participate in HMIS data collection. Coordinate with annual point-in-time (PIT) and housing inventory count (HIC), conduct housing and service gap analysis, and participate in the Consolidated Plan process. At the time of contract execution, the Homeless Program Manager (HPM) will convene CoC stakeholders (currently 75+ attendees) to address resource gaps and modernize the system. Timeline for implementation includes coordination and publication of written agenda, meeting minutes and planning documents posted on the CoC website and provided to CoC stakeholders:

- 1. Coordination of CoC planning activities Month 1, monthly to completion
- 2. Project and System Monitoring and Evaluation Month 2, monthly to completion
- 3. Policies and Procedures for HUD Compliance Month 3, monthly to completion

The CoC stakeholders and CoC Board will participate in subsequent planning activities to accomplish the goals identified.

An estimate of 11 hours per week is needed to coordinate the CoC planning activities to include developing a diverse cross-sector stakeholder attendance at CoC meetings, schedule and facilitate the meetings, prepare communications and documentation in support of action items, perform technical research, perform on-site project monitoring, analyze system and project performance, develop working documents for review by the CoC partners, prepare and finalize written policies and procedures approved by the CoC, and provide training and technical support in support of CoC policy and HUD compliance.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The HUD funds will be used to leverage additional funds to effectively address an increasing need for homeless services through comprehensive planning activities by the CoC. The grant will improve the CoCs ability to operate within a collaborative governance process, monitor and evaluate the outcomes of CoC and ESG projects using standardized and transparent evaluation criteria, coordinate and submit CoC Consolidated Application process, develop and monitor a CoC system that complies with Fair Housing to include Equal Access Act and anti-discrimination, and establish policies based on CoC and ESG standards that creates consistency and support across the CoC network of providers and consumers. The CoC Planning grant support oversight to the HMIS governance.
