# Ms. Stacey Darden, Boys & Girls Aid, "Adoption Services and Supporting Adoptive Families"

Stacey Darden presented an overview of the Boys & Girls Aid *Options Program* and welcomes the opportunity to create partnerships with other agencies. Boys & Girls Aid is a state licensed child welfare agency offering housing services in Washington County. The premise behind the Options program is to provide all-options pregnancy counseling to any woman experiencing an unintended pregnancy. They inform the pregnant woman to help her make the best choice for herself and her family. All services are free, non-directive, non-coercive, and unbiased. About 1 to 2 percent of women move forward with an adoption plan and the remaining choose other options. Fees received from adoptions are used to fund the Options counseling services. # Mr. Tim Davis, Washington County Office of Community Development, "Washington County Wood Stove Program"

Tim Davis explained the Wood Stove Exchange is a collaborative program with the Department of Health and Human Services and the Office of Community Development. The goal is to exchange old uncertified wood stoves with new certified wood stoves, pellet stoves, gas devices, or electric heat pumps. The larger goal is to reduce the particulate in the air by exchanging 700 wood stoves in five years. In the first 15 months of the program it has already exceed their goal of 50 stoves with 134 exchanges out of 400 applications. In the first year of exchanges 9 ½ tons of particulate have been prevented as well as over 40 tons of other gases and pollutants. Most people prefer a non-wood device. Rebates and grants are available to people to help offset the cost of the exchange. Several avenues of marketing are being utilized regarding this program including social media, bill inserts, and postcards. Each avenue of marketing is being tracked to assess which methods have the best response. The most recent survey showed recipients are enjoying their new units. This program is available to both homeowners and renters with approval of the landlord. For more information on the program visit www.WoodstoveExchange.com.

Alma Hernandez reported on grant funds that will be used to create a mentorship program for homeless youth in Washington County school districts with dropout prevention. Two coaches will be hired to recruit volunteers to mentor students in grades 9 through 12 in the Hillsboro and Beaverton school districts. This year will focus on grades 11 and 12 and next year grades 9 and 10 will be added. Abelmar Garcia-Gomez will be looking for mentors in Hillsboro, Banks, Forest Grove, and Gaston. Mary will be looking for mentors in Beaverton, Banks, Tigard, and Sherwood. The mentorship will be student driven and each mentor will be given a survey to best match the student and mentor. Work is being done with the Beaverton mediator to address truancy issues before schools have to take action.
