The Boys And Girls Aid (BGA) Transitional Living Program (TLP) provides housing and supportive services to assist runaway and homeless youth in obtaining safe and stable housing. The program serves youth ages 18 to 24 years to include 4 unaccompanied homeless young adults and 3 homeless parenting adults within six units of scattered-site housing leased by BGA.

Comprehensive wrap-around services include case management, educational support, enrollment in vocational and job programs, mental health and addiction sessions. Financial assistance is provided for housing, utilities, and household supplies.

The CoC has established written standards for screening, assessment and referral that leads to housing placement. Outreach and referral to the TLP is conducted in alignment with Community Connect, the Continuum of Care (CoC) centralized assessment system, and the mobile assessment team serving runaway and homeless youth. The HomePlate Youth Outreach and Boys And Girls Aid mobile assessment staff maintain regular communication with GED and vocational programs, law enforcement, mental health service agencies, health care providers, homeless shelters, and partner agencies serving homeless persons who meet the HUD definition of homelessness

The SafePlace Shelter for youth is operated by Boys And Girls Aid, and is the only shelter in Washington County serving runaway and homeless youth ages 12 to 21 years for up to 120 days. If youth staying at the shelter wish to continue in the program after 120 days or after turning 21 years of age, they are considered eligible for the TLP and can ultimately make a seamless transition into the program. This continuum is highly effective for youth as it provides opportunity to become familiar with the staff and program as staff engage with the homeless youth in case management, assessment and skill building that will help determine the best housing plan.

Boys And Girls Aid is active in CoC strategic planning and efforts to increase resources and develop system changes identified in the County's homeless plan and Consolidated Plan that include priorities established in Here, Together, the Federal Strategic Plan.

Boys & Girls Aid's President & CEO has put into writing a "Boys & Girls Aid is not neutral" stance against racism and a statement about our intent to have an anti-racist organization. We strive to ensure that our programs demonstrate racial equity in the most effective ways possible, which is an ongoing learning process for staff that has involved formal self-assessment (both personal and programmatic), training, discussion, programmatic changes, messaging from agency leadership, and input from clients. The agency has an active DEI committee that guides this work, with a dedicated youth programs work group.
