Program Overview

• Purpose: Five Year Strategic Plan that builds on an intensive community engagement process to assess housing and community development needs and prioritize investment of an estimated \$35 million of federal investment over the next 5 years.





Community Development Block Grant (CDBG)

- Community Development Block Grant funds support infrastructure projects, facilities projects, single family housing rehab projects, and key public services.
- The major objectives for the CDBG program are:
 - Meeting the needs of the low- and moderate-income populations and areas.
 - Eliminating and preventing the creation of slums and blight.
 - Meeting other urgent housing and community development needs.



Emergency Solutions Grant (ESG)

- The Emergency Solutions Grant (ESG) provides federal funds to assist individuals and families to quickly regain stability in permanent housing after experiencing a housing crisis or homelessness.
- The four program categories are:
 - Homeless Prevention
 - Rapid Re-housing
 - Street Outreach
 - Emergency Shelter.



HOME Investment Partnerships Program

- HOME Investments Partnership Program (HOME) supports the production of regulated affordable housing within Washington County.
- Home Program Activities Include:
 - Acquisition financing
 - Rehabilitation financing
 - New Construction Financing
 - Community Housing Development Organization (CHDO) operating costs.



Summary from Services Workgroup at Kick Off Event

- Strengths:
 - Collaboration between groups

 - Long wait times
 - High case loads
- Challenges/threats:
 - Not in My Back Yard (NIMBY)
 - Big need with decreasing funding

 - Use of qualitative data to measure success
