January 2023

- Encouraged staff to develop and share survey with community.
- Mapped required activities from funders that advisory bodies will oversee.

March 2023 Survey

- Provide input to help guide work forward.
- Build on successes and address areas for improvement.






Which advisory bodies do you participate in?

Part 1 Theme: Providing information and resources for accessing homeless services & Streamline processes for accessing resources and services.

- Invest in partnerships with medical institutes/CCOs for preventative measures.
- Provide accessible communication channels for homeless individuals without electronic access.
- Implement inter-county transfer options for homeless individuals.

Part 2 Theme: Providing information and resources for accessing homeless services & Streamline processes for accessing resources and services.

- Make it easier for homeless individuals to get the help they need.
- Provide more support for homeless individuals who are trying to get back on their feet.
- Increase collaborations with school districts and early childhood learning centers.

Theme: Address public fears and concerns through clear communication and transparency.

- Include youth representation in meetings with appropriate compensation.
- Simplify language and reduce overwhelming acronyms.
- Prioritize meaningful discussions over large agenda items.
- Improving inter-agency communications and collaborations
- Community engagement and sensitivity to public concerns

Survey Respondent quote:

"Addressing public fears and concerns, but rather treating them as prejudice towards the vulnerable."





Theme: Reduce the number of committees and streamline processes for more effective decision-making.

- Clarify the roles of different agencies involved in addressing homelessness.
- Streamlining processes for accessing resources and services

General oversight & accountability



- Advise on system planning, policy development, and program oversight
 - Annual workplan and budget planning
- Develop and maintain governance charter
- Bodies are diversely representative and community-based
- Convene an open membership meeting to coordinate system implementation
 - Issue public invitation for new members no less than annually
 - > Review Governance Charter/Bylaws annually
- Ensure the provision of a Lived Experience advisory body

Staff Recommendation: Single Advisory Body with clear lines of accountability to:

- Open Membership
- Lived Experience bodies
- all Technical Advisory Committees



Performance management & system oversight



- Ensure and approve system reporting (timeline below)
 - ➤ Overall system plan updates (LIP, A Road Home, Consolidated Plan) and annual reports
 - > HUD required reports: PIT, HIC, LSA, SPM, APR, & CAPER
 - > Equitable outcomes analysis and racial disparities
- Ensure and conduct grievance review processes
- Establish and regularly review written program standards

Performance management & system oversight



- Establish system performance targets by program type and population
- Ensure provision of data management system (HMIS)
 - ➤ Monitor participation in the HMIS
 - > Review and approve policy changes as needed
 - > Review and approve privacy, security, and data quality plans
 - Establish user groups as needed to review data entry workflows and recommend process changes

Staff Recommendation: Standing Subcommittee.



HUD Program and process oversight



- Oversee and ensure annual HUD NOFO and ESG grant processes
 - ➤ CoC rating and ranking
 - ➤ Issue RFP for new projects
 - **➤ ESG Consultation**
- Review overall contract allocation process
- Reallocate funding as needed to address program performance, utilization, or significant changes in community needs or resources
- Approve Submittal of HUD Application
- Convene technical workgroups as needed

Community Connect System Oversight



Review and approve policy changes as needed

- Regular and ongoing process evaluation, oversight, and system improvement recommendations
 - ➤ Conduct and review findings of annual Partner Agency and Consumer survey
- Convene technical workgroups as needed

HOMELESS ADVISORY BODY (HAB)

- General oversight & accountability
- Convened by BCC
- Diverse Membership
- Consistent with Metro, HUD & County requirements
- Makes recommendations to BCC and staff re budget/program priorities
- Program evaluation & improvements
- Systems integration & alignment
- Approves reports & plans to HUD, Metro and other funding jurisdictions

Permanent Sub Committees

- HUD or other funder requirement
- Convened by HAB & included in Bylaws
- Includes HAB & community members with related expertise.

Temporary Technical Work Groups

- Convened by staff as needed or requested by HAB
- Contracted and system partners convened by program area to coordinate and solve program needs
- Prepare technical feedback for advisory bodies as requested.
