The Reentry Housing Program experienced a de-obligation of funds this past fiscal year in the amount of \$1,386.77, as our team had some challenges filling open positions and we had no participants in the housing search phase. This fiscal year we worked closely with WCDHS to manage the funds and the spending of the grant. At the end of the fiscal year because of the amount of people graduating the program and the open staff positions we ended with 13 individuals housed. Our goal for the next fiscal year is to work with WCDHS to identify the number of individuals needing to be housed in order to utilize all of our funding.

Reentry Housing is a Housing First rapid rehousing program using tenant-based rent assistance (1 to 24 months) to provide 20 units in scattered-site housing with locally funded client-centered services targeted to justice-involved homeless adults experiencing barriers to housing and employment.

Discharge planning occurs for all persons exiting the Jail, however, homeless individuals arrested for one of a variety of misdemeanor violations is taken to Jail and released in a few hours with a future court date, providing little time to achieve a successful housing placement upon discharge. The HOPE Deputy (Homeless Outreach Program and Enforcement) assists Outreach Workers to provide social services and referral to the CoCs homeless coordinated entry (CE) system. This approach addresses a series of goals to provide a quality of life in the community for both housed and non-housed residents. The HOPE data reports an increasing number of justice-involved homeless adults living on the streets with 89% incarcerated in the past 24 months. WCDHS, Community Corrections, Sheriff's Office, and the Jail analyzed the costs when homelessness continues to perpetuate and developed the Reentry Housing project in partnership with New Narrative to break this vicious cycle. The CoC supports this project to end homelessness for justice-involved individuals and to prevent an increasing number of homeless-related service calls to law enforcement as individuals seek to meet their basic needs while living on the streets.

Outreach and referral to the Reentry Housing program will come through the CE system. WCDHS will administer the rent assistance, perform HQS inspections and calculate rents for program participants in partnership with New Narrative, Inc., a nonprofit service and housing provider agency with experienced housing navigation and peer mentor staff. The project will leverage local funding to provide 1 FTE Housing Navigator with existing landlord relationships, 1 FTE Peer Mentor and services to: a) assist the individual to complete housing applications and work with landlords to address negative rental and criminal history to overcome housing barriers; b) provide housing counseling, search and move-in supports; c) tenancy supports to achieve housing stability; and d) assist in obtaining photo identification, provide case management services, access mainstream benefits, employment, mental health and substance treatment, life skills, and create positive support systems. The project will include culturally specific services delivered through partner organizations and is focused at ending homelessness for justice-involved individuals in alignment with A Road Home, Washington County Consolidated Plan and Home, Together: The Federal Strategic Plan to Prevent and End Homelessness. Staff track referrals to ensure equitable/inclusive service access/delivery.
