Washington County Supportive Housing Services Funded Shelters

Shelter System Referral Process: Referrals to shelters funded through Washington County Supportive Housing Services are completed through the Homeless Management Information System (HMIS). People who do not have access to HMIS are able to contact Community Connect by phone or email. Community Connect can complete Shelter Referral Assessments for people seeking shelter. Currently, there is a waitlist for shelter beds/units.

Referral Process:

- Option A HMIS user completes a Shelter Assessment and Referral for participant(s) seeking shelter.

All Referrals Prioritized by:

- Over 55 years old; Medical or judicial discharge; Length of literal homelessness; Unsheltered status; Connection to Enhanced Case Management (Housing Case Management Services (HCMS), Rapid Re-Housing (RRH), Veterans Affairs Supportive Housing (VASH), Shelter + Care (SPC), Continuum of Care programs (CoC))
- Congregate and Non-Congregate Shelter:
 - o 1st priority: households enrolled in an Enhanced Case Management Program
- Family Non-Congregate Shelter:
 - 1st priority: households with minor children enrolled in Enhanced Case Management
 - 2nd priority: households with two or more adults enrolled in Enhanced Case Management
 - \circ 3rd priority: households with minor children
 - o 4th priority: households with two or more adults

Shelter Eligibility: An individual will qualify for shelter by being identified as Population A or B, defined as:

- Population A: people with extremely low incomes, and one or more disabling conditions, and who are experiencing or at imminent risk of experiencing long-term or frequent episodes of literal homelessness;
- Population B: people who are experiencing homelessness or have substantial risk of experiencing homelessness.
