HB 3115 OVERVIEW

Martin v. Boise

- Prohibiting camping without an available shelter bed is a violation of a person's 8th Amendment rights
 against cruel and unusual punishment
- A bed is available only if it is one that may actually be used by the specific individual (ex. a shelter that does not allow animals is not available for an individual with a pet)
- Cities may adopt reasonable time, place, and manner regulations
- Generally interpreted as only applying to criminal ordinances

Johnson v. Grants Pass

- Reaffirmed and expanded Boise
- Allowing sleeping in public places, yet prohibiting campsites with bedding or a structure is unconstitutional
- Applies to both civil and criminal ordinances

HB 3115

State law that codified Martin v. Boise and says that all cities must be in compliance by July 1, 2023

Beaverton Implementation

- BPD Bike Team primarily enforces TPM
- Implementation began during focused outreach as part of county's LC3 Process
- Reduced camping and increased resourcing for folks that were camping in Central Beaverton near the BCL
- 6 Month report to be provided to Beaverton City Council later this month

 - Policy language review

Hillsboro Implementation

Primarily enforced by CIT, Bike and Code Compliance team, with a focus on service connection.

Ongoing issues and concerns:

- Belongings during the day (storage on public property allowed for limited time but not sufficient for need)
- Myths/fears about homelessness persist
- High volume of calls (police resources)
- Safe Park options-looking for a Hillsboro site

Tigard Implementation

Focused Patrol Officer enforces Time, Place, Manner rules

Ongoing issues and concerns:

- Belongings during the day
- Limited enforcement resources
- ADA compliance

Tualatin Implementation

Community Services Officer enforces Time, Place, and Manner

Belongings during the day
