Ordinance Purpose and Summary

Ordinance No. 734 grants a one-year extension of all preliminary land use approvals and all final approvals of subdivisions, partitions, and property line adjustments that are set to expire between the effective date of this ordinance and one year from that effective date. The purpose of this ordinance is to address the unprecedented downturn in the real estate market and the credit crisis.

Who Is Affected

Applicants and developers with preliminary land use approvals and final approvals of subdivisions, partitions, and property line adjustments that are about to expire.

What Land is Affected

Parcels and tax lots with current preliminary land use approvals and final approvals of subdivisions, partitions, and property line adjustments.

Key Provisions

Ordinance No. 734 grants an automatic one-year extension of all preliminary land use approvals and all final approvals of subdivisions, partitions, and property line adjustments that are set to expire between the effective date of this ordinance and one year from that effective date.

Hearings will be held in the Shirley Huffman Auditorium in the Charles D. Cameron Public Services Building, 155 North 1st Avenue, Hillsboro, Oregon.

On July 6, 2010, the Board of County Commissioners (Board) may choose to adopt the ordinance, make changes to it, continue the hearing to a future date, or reject the ordinance. If it is adopted, it would become effective on August 5, 2010.

AND FINAL LAND USE APPROVALS THAT ARE SET TO EXPIRE BETWEEN THE EFFECTIVE DATE OF THIS ORDINANCE AND ONE YEAR FROM THAT DATE

SUMMARY:

Ordinance No. 734 would grant an automatic one-year extension of all preliminary land use approvals and all final approvals of subdivisions, partitions, and property line adjustments that are set to expire between the effective date of this ordinance and one year from that date. The purpose of this ordinance is to address the continued downturn in the real estate market and the credit crisis. If the ordinance is adopted by your Board on July 6th, the effective time period would be August 5, 2010 to August 5, 2011.

On June 16, 2010, the Planning Commission conducted a public hearing for this ordinance. The Planning Commission voted 6-1 to recommend that the Board adopt Ordinance No. 734.

This agenda has been prepared in advance of the staff report for the July 6th hearing. The staff report will be provided to the Board and the Board's clerk prior to the hearing date. Proposed Ordinance No. 734 is posted on the county's land use ordinance web page at the following link:

Page 1 – ORDINANCE 734

An Ordinance Granting a Second One-Year Extension of All Preliminary and Final Land Use Approvals that Are Set to Expire Between the Effective Date of this

Ordinance and One Year from that Date

The Board of County Commissioners of Washington County, Oregon, ordains as follows: SECTION 1.

- A. The Board of County Commissioners ("Board") finds that builders in Washington County, even with the automatic one-year extensions granted by and through the adoption of Ordinance 716 on July 7, 2009, are struggling to move forward with approved preliminary and final approvals given the continued, unprecedented downturn in the real estate market and the credit crisis.
- В. The Board finds that to avoid expiration of existing approvals it is appropriate to grant automatic extensions for a second one-year period to provide additional time for builders to respond to market constraints.
- C. Under the provisions of Washington County Charter Chapter X, the Department of Land Use and Transportation has carried out its responsibilities, including preparation of notices, and the County Planning Commission has conducted one or more public hearings on the proposed amendments and has submitted its recommendations to the Board. The Board finds that this Ordinance is based on that recommendation and any modifications made by the Board. as a result of the public hearings process.

D. The Board finds and takes public notice that it is in receipt of all matters and information necessary to consider this Ordinance in an adequate manner, and finds that this Ordinance complies with the Statewide Planning Goals, the standards for legislative plan adoption as set forth in Chapters 197 and 215 of the Oregon Revised Statutes, the Washington County Charter, the Washington County Community Development Code, and the Washington County Comprehensive Plan.

SECTION 2

Notwithstanding any existing provision under the Community Development Code, this ordinance shall grant an automatic one-year extension of all preliminary land use approvals and all final approvals of subdivisions, partitions, and property line adjustments that are set to expire between the effective date of this ordinance and one year from that effective date. No additional process, application or fee is required for any of these automatic one-year extensions.

SECTION 3

All other Comprehensive Plan provisions that have been adopted by prior ordinance, that are not expressly amended or repealed herein, shall remain in full force and effect.

SECTION 4

If any section, clause, phrase, or word of this Ordinance or its application shall for any reason be determined invalid or unenforceable by a body of competent jurisdiction, the validity of the remainder or its application and all portions not so stricken shall not be affected thereby and remain in full force and effect, and any provision of a prior ordinance amended or repealed by the stricken portion of this Ordinance shall be revived and again be considered in full force and effect.
