 - W70/W71—Helvetia/Verboort/Buxton/Timber (NW rural county)
 - W80/W81—Scholls/Farmington/Gales Creek/Cherry Grove (SW rural county)


Crash Maps


North county


South county

Rural Fatal Crashes Investigated by CART*

- April 1, 2021-April 1, 2022
 - March 2022: SW Rood Bridge Rd/SW Burkhalter Rd, bicyclist struck by car
 - June 2021: 7200 block SW Rood Bridge Rd, single vehicle, driver deceased
 - June 2021: 32100 block NW Hwy 47, M/C crash into deer, driver deceased
 - May 2021: 32300 block SW TV Highway, pedestrian struck while walking in road (non-intersection)
 - April 2021: 6600 block SW River Rd, single vehicle, driver deceased

*Although some of the above crashes occurred on state highways, they were investigated by WCSO as the primary law enforcement agency. Other fatal crashes may have occurred in rural Washington County that were not investigated by WCSO or CART, such as those investigated by the Oregon State Police.

Traffic Complaints

- New WCSO traffic complaint database
 - Central repository
 - TSU primary users
 - Available to all of patrol
 - All types of traffic complaints
 - Speeding
 - Radar trailer requests
 - Aggressive driving
 - Failure to obey traffic control devices
 - Failure to obey crosswalks
 - Failure to obey school bus lights
 - Parking violations
 - “Other”

Top Complaint Locations Oct 2021 to Apr 2022

W40/W41:

- SW 150th/SW Rosario—CMV traffic
- SW Peachtree/SW Beef Bend—Speeding
- SW Roy Rogers Rd—Speed, aggressive driving

W70/W71:

- Sunset Hwy—School bus lights, aggressive driving
- Verboort, Cochran, Hartwick, Ketcham Rd—School bus lights
- NW Scotch Church Rd—Speeding

W80/W81:

- SW River Rd/SW Rosedale—Speeding
- SW Vanderschuere Rd/SW Neugebauer Rd—Fail to obey TCD
- SW Stringtown Rd/SW Dilley Rd--Speeding
