This matter having come before the Washington County Board on July 22, 2025, and It appearing to the Board that:

WHEREAS, that the government of Washington County is of and for all residents, workers, and visitors in Washington County; and

WHEREAS, Washington County affirms one of the foundational principles of the United States is that all residents, workers and visitors are treated fairly and equally under the law; and

WHEREAS, longstanding federal and state civil-rights laws protect individuals from discrimination and these protections serve as a bedrock supporting fairness and equality of access and opportunity for all; and

WHEREAS, Washington County is committed to First Amendment-protected free speech and other rights and protections guaranteed by the United States Constitution, as well as complying with all applicable laws prohibiting discrimination in the provision of its services, benefits, programs, and activities; and

WHEREAS, longstanding federal and state civil rights laws, such as the Civil Rights Act of 1964, the Age Discrimination Act of 1975, the Americans with Disabilities Act of 1990, the Rehabilitation Act of 1973, and Oregon Revised Statutes Chapter 659, prohibit

discrimination and establish fairness and equality of access and opportunity as a foundational legal principle; and

WHEREAS, every Washington County resident is afforded these protections; and WHEREAS, that Washington County is committed to advancing policies and programs that enable access and opportunity for all without regard to race, color, disability status, ethnicity, national origin, or other classes protected by federal or state law; and

WHEREAS, Washington County remains committed to providing respectful and compassionate service to residents, workers and visitors in Washington County, with a focus on improving outcomes for individuals, as part of its commitment to responsible stewardship, results-based service excellence, continuous improvement, and effective and efficient government operations; and

WHEREAS, Washington County affirms its commitment to community partnerships in support of the County's and partners' ability to respond effectively to community input and priorities; and

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, that on this 22nd day of July, 2025, the Washington County Board of Commissioners will:

- 1. Understand the principles of access and opportunity as follows:
 - Access refers to the intentional design and implementation of systems,
 environments, and practices that enable all individuals to obtain and utilize
 resources, services, and opportunities. This involves proactively identifying and
 removing physical, technological, and linguistic barriers that may hinder full
 participation. By fostering environments where everyone can engage

- meaningfully, access ensures that individuals are not excluded due to factors such as ability, background, characteristics, or socioeconomic status.
- Opportunity denotes the fair and just provision of chances for individuals to
 pursue personal and professional wellbeing and growth, contribute to decision making processes, and achieve their potential. This principle emphasizes the
 importance of creating conditions where one's background, characteristics, or
 circumstances do not predetermine success, rather success is attainable
 through fair and just support, resources, and recognition of individual talents,
 efforts, and merit.
- Commit to ensuring that we spend the public's dollars in a manner compliant with federal, state, and local laws as amended, including those that protect Washington County residents, workers, and visitors from unlawful discrimination, such as:
 - Civil Rights Act of 1964
 - Age Discrimination Act of 1975
 - Americans with Disabilities Act of 1990
 - Rehabilitation Act of 1973
 - Oregon Revised Statutes Chapter 659A
- 3. Direct the County Administrator to:
 - Conduct proactive programmatic reviews twice a year to ensure compliance with federal and state non-discrimination laws;
 - Implement the Access and Opportunity Framework across all County operations;

• Engage in consistent and proactive outreach with community partners.
