# **Protocols for CCI Meetings**

### Commissioner of the Month

Special Guest County Chair Kathryn Harrington will visit this month to share some of her thoughts and answer a few of our questions.

- Every member of the community is offered 30 minutes if the Chair's time, to request time, please use the constituent email
- Commissioners have made efforts to be more transparent and inclusive of community engagement through budget videos. Next quarterly commission town hall will be in September.
- o Openness, community, and engagement is important to chair Harrington
- Equity, and centering equity is important to center equity in our policies and practices.
- Homelessness, and supporting folkx transitioning into stable housing and affordable housing
- Addressing community needs, Center for Addictions and triage and treatment, improvement for the building will happen, the center will be at the previous WACCA building. There will be two locations, one for inpatient services and the other for general services. Investments in behavioral health, working to ensure appropriate funding for parole and probation and juvenile justice.
- County strategic plan was adopted in the 1980s, the county landscape was different.
   The community will fully engage in the updating of the county strategic plan, strategic

families and financial planning. Early releases have been happening for over 10 years from the jail due to space limitations.

Reapportionment: Public input process will begin soon, online and community groups.

## Court Appointed Special Advocates

The region is currently seeing an uptick in families entering the family court systems in Washington, Multnomah and Columbia counties which means children and youth in the community need Court Appointed Special Advocates (CASA) to represent their interests. Jazmin Roque, Volunteer Recruiter for CASA, will present how to volunteer for this special service.

- Most counties have a casa program. In Washington county they are seeing an increase
  in cases coming in which is increasing the need for CASAs in the area. Cases are on a
  waitlist currently. CASAs only get assigned one case at a time.
- Unique need, some families will benefit from bilingual Spanish speaking CASAs. Being bilingual is not a requirement.
  - You don't need a background is social work or legal system to participate.
  - Must be 21, and have desire/passion for advocacy and time
  - CASA provides training and supports for volunteers
  - CASAhelpskids.org
  - First step is to sign up for an info session. Info sessions are held virtually
  - Next CASA training will happen in September

### • Stephen Roberts, Director of Land Use & Transportation

Mr. Roberts will join us to discuss the force and effect of County Community Plans, Road Standards, and Long Range Transportation plans. These were called into question as a result of the County's approval of the Thompson Crossing development, which granted many exceptions to Arterial Road Standards and abandoned the county's previous plans to straighten the adjacent section of NW Thompson Road. He will respond to our questions.

- Received an email from Prashanth Ramesh and his slide deck. He forward the email to his team to review the design of the roadway.
- Bruce: Would there be an advisory committee for the update work: Answer: Not sure at the movement.
- Brian Young: on the intersection of Thompson and Hibbard, "I want address how dangerous this intersection is and if there is anything that can be done to address this. like a signal. Also, there is a lot of speed racing around here" Brain concurs with Prashanth Ramesh's concerns
- Prashanth Ramesh: resident of the NW Thompson and NW Hibbard drive. He shared a PP

- 35 mph is the proposed speed limit in the Thompson road area
- Greg M: "The straightening of Thompson has been on the books for decades. I would suggest moving the stop line on Hibbard North out to toward that yellow dot but paint in a crosswalk across Hibbard North, with the stop line directly north of the crosswalk, it is hard to move your car up to try see in both directions AND watch out for peds and school children"
- Arterial Road Section: Will have a road with 3 lanes, bike lane and sidewalk. The design speed will be the biggest change going from 35pmh from 45mph
- Brian Young: "What does it take to put a light control in that section" a signal seems to be an easy way to solve the present issues: they rely on traffic signals that fall within the engineering criteria to determine if a traffic control signal is appropriate for the area.
- Q Virginia: "Can you please describe the process that takes place within LUT when deciding to

  conditions and do not reflect the property rights, land ect that are not taken into consideration.
  Each code has a different process and staff review for development.
- Where to file an object when a builder is breaking a code? Where do you file a complaint?
