Lucy Bailey & Deputy Holmes updating

- Lucy has left postcards in the library location for upcoming recruitment opportunities for the Sheriff's Office
- 9pm Routine – (or whenever you call it a night) – checklist of home safety
- Shared service calls map (not crime, just a call that came in to dispatch)
- Deputy Holmes – We live in a very safe area in terms of person safety; most calls property-related around TV Hwy
- Also discussed 9p routine & general safety (e.g. don't leave car running without anyone in it)
- Warning against phone scammers – check your own accounts, not through calls or email
- Best of luck to Sheriff Pat Garrett in his retirement

- Becky asked about camping enforcements – calls for those generally in daytime unless people trespassing
  - County trying to set up sanctioned camping areas

## **No updates from Fire or Water Departments**

### **CCI – Committee for Citizen Involvement**

Bruce Bartlett speaking

- CCI is series of subcommittees
- Interest in protecting natural areas during development in Washington County
- Incumbent to track long-term effects of development codes. To change a code is about a 2-year process
- Office of Community Engagement has started a revisioning with CCI
- Commissioner Fai has regular meeting sessions regarding codes (only commissioner who has done this) – Bruce interested in seeing what would be good to promote – 2-way communication with citizens and commissioners
- Want way for citizens to gather & address neighborhood problems (e.g. speeding in neighborhoods)
- Had an issue where they held a voters' forum and a white supremacist came in and tried to distribute literature. Concern is that CPO is entirely volunteer and anyone can get elected without vetting or background check
- CPO6 hybrid between rural & urban by being not incorporated (ESPD, for example) – “urban needs, rural government”
- Community question – a lot of alphabet agencies just mentioned, can we get a list of what they are and what they do, easy to access to know who to contact for needs
- New land brought into UGB has to be developed by a city, which means annexation

Gen discussion

- Also need means of passing down information/wisdom from one chair to another and access resources – e.g. upload our own minutes or access the email box
- Becky – hopeful by time of next CPO elections, have several people interested in steering committee positions
- Open House for 4-H, 10-2 at fairgrounds this Saturday Oct 7
- CPO1 has a talk on domestic terrorism at their next meeting, including different hate groups – trying to get community engagement to do blanket announcement
- Does CCI have transportation subcommittee? Sort of – has LUT so covered under that
- Community concerns about incoming subdivision and changes to development master plan
- Governance – we have 2 cities within county boundaries
- Haika Mushi – works with Intel & has been attending meetings
- Can get reps or other politicians involved
- Plans – next month have LUT come out; after that have Water
- Significant Natural Resources Open House on Oct 21

- Becky – interested in more info about project/proposal to incorporate Aloha
- Looking to meet with people interested in volunteering before next month's meeting
