- 4. **FEATURE PRESENTATION Cornelius Fire Levy** presented by Peter Brandom, Cornelius City Manager, and Jim Geering, Fire Chief

The current local option levy to support fire services has been in place since 2015. It was renewed by voters in 2019 at \$0.487 per \$1,000 of assessed property value and expires in 2024. If the proposed ballot measure is approved, it would replace the current levy with \$1.461 per

\$1,000 assessed value. For a property assessed at \$250,000, the new levy would amount to an assessment of approximately \$30.41/month or \$365/year. It would help the Fire Dept. meet increased costs and call demand, reduce 911 response times and improve advanced lifesaving medical treatment.

The Cornelius Fire Department has historically been volunteer dependent, but today's professional and family demands have altered volunteer services, making it challenging to recruit and retain volunteer firefighters. The responsibilities of fire departments have also expanded to cover wildfires and call volume has increased. In addition, Cornelius has only 0.49 fire fighters per capita, which is low, and Fire Chief Jim Geering also serves as the Fire Chief of Forest Grove. It is difficult for their current staff of seven fire fighters to cover three daily shifts.

Between grant funding and the proposed levy, the goal is to provide adequate staffing to meet the needs of the community and improve response times efficiently.

If the levy passes, it will take effect July 1, 2024.
