8/3/2014 3:37 AM	N Davis & Fremont – Dog barking; owner warned
8/3/2014	Responded to person in mental health crisis
8/3/2014 10:02 AM	N 10 th & Adair – Non-injury traffic crash blocked the southbound lanes; both vehicles had to be towed.
8/3/2014 10:52 AM	S 7 th Court – Vehicle was backed into on a farm north of Cornelius during a party. Driver accepted fault and offered to pay to repair damages.
8/3/2014 12:51 PM	N 19 th Ave – Graffiti applied during the night; ongoing problem at this location.
8/3/2014 1:45 PM	S 20 th & Alpine – Wrong-way driver reported; deputy tracked and cited driver for no operator's license.
8/3/2014 5:35 PM	N 20 th – Parking lot crash, no injuries.
8/3/2014 6:34 PM	Baseline – Persons contacted in the parking lot at the request of Fred Meyer personnel. Male and female are homeless and having been staying in their vehicle. Deputy discussed other options and they agreed to move along.
8/3/2014 7:24 PM	N Adair – Person arrested for shoplifting at Walmart.
8/3/2014 8:37 PM	S Jasper – Found blue tape arrows on roadway leading to address 10 blocks away. Contacted resident who admitted placing them to advertise her garage sale. Deputy applauded her creativity, but discussed the legality of placing unauthorized markings in a public roadway. Arrows were removed.
8/4/2014 9:20 AM	N 15 th & Fremont – Parking complaint; warned owner.
8/4/2014 8:02 AM	N Barlow - Unknown person wrote gang graffiti in the bathroom and on a park bench.

8/4/2014 8:03 AM	S Dogwood & 14 th - Driver ran stop sign in plain view of deputy. Driver was in a hurry to get a child to school. Cited for Failure to Obey a Traffic Control Device.
8/4/2014 10:50 AM	Baseline St – Disappointed patron threw down a rototiller when leaving Sears store. No damage done.
8/4/2014 1:10 PM	Parent reported son locked in home bathroom and doing drugs. Deputies responded; youth was taken into custody on a probation violation detainer for drug use.
8/4/2014 4:39 PM	N 20 th – Dog left in vehicle with windows down, but 96 degrees outside. Deputy referred; dog control responded.
8/4/2014 4:36 PM	S 26 th – Gas station customer left without paying, thinks he might have forgotten to pay while loading items. Deputy contacted mother who said son is forgetful and she gave cash to the deputy to cover the bill.
8/5/2014 9:30 AM	S Cherry & 1 st – Child reported to an adult that he saw a person riding away on a bike with the neighbor's air conditioning unit. Suspect left backpack and tools behind.
8/5/2014 5:40 PM	Baseline & N 26 th – Assist motorist; vehicle won't go into neutral; called tow.
8/5/2014 6:17 PM	N Adair – Chevron patron concerned about a dog locked in car. Deputy found temperature was 72 degrees and cool breeze blowing in through windows. Dog was happy and fine.
8/5/2014 9:34 PM	Multiple reports of shots fired and fireworks. Residents provided fast and excellent information that enabled deputy to respond, hear the mortars and identify a possible suspect vehicle.
8/5/2014 10:50 PM	S Dogwood – Vehicle broken into during the night. Unknown if gas was stolen.
8/5/2014 11:25 PM	S Beech Street – Unwanted person knocking on door. Appears to be on drugs. Left after talking with deputy.
8/6/2014 01:19 AM	Baseline St – Bar patron reported very intoxicated male behind the wheel of a car. Refused taxi service.
8/6/2014 7:32 AM	10 th Ave / S Cherry – Loose dog returned to owner, side gate unlatched.
8/6/2014	S 10 th – Possible drug activity; deputy contacted occupants, no evidence of drug activity.
08/06/2014 6:20 PM	Baseline – Assisted motorist, pushed broken down car to nearby business.
08/06/2014 8:46 PM	N Barlow – A group of kids age 6-10 years were fighting. Dad came out and tried to get 10 year old to apologize to his son who was crying; put his hand on neck and told him to get his mom. The mom called police. No arrests, just talked to all. If further issues, parents must talk to each other.
08/08/2014 5:11 PM	N Adair - Caller reported that her mentally delayed son was called harassing names by a patron at Little Italy restaurant; he has done it before. Identity not known, person not present. The woman was directed to call police if it happens again.
08/08/2014 9:19 PM	S Alpine to S 8 th – Woman reported son took off running after person who just slashed tires on their jeep and truck. Suspect then pulled a knife. Deputies arrested suspect for Criminal Mischief; fair amount of damage to both vehicles.
08/08/2014 11:38 PM	S 25 th Pl – noise complaint, ongoing issue. Deputy responded, no music heard, no contact.
08/09/2014 5:38 AM	N 15 th – Deputy responded to a medical call involving a baby; he briefly

08/09/2014 8:00 PM	performed CPR until medical arrived 1-2 minutes later and transported the child.
08/09/2014 08:26 PM	N 13 th & Barlow – person found a wallet by the carwash in Cornelius. Deputies returned it to the owner in Hillsboro. Multiple calls – shots fired. Again, citizens did excellent job of calling quickly with good information. Shots actually confirmed to be fireworks.
