STATEMENT OF CHANGES IN ACTIVITIES and SOURCES OF FINANCING *

2022-23 is the 12th year of funding for the Downtown Hillsboro Urban Renewal Area. Property values are increasing in this renewal area which is increasing the budgeted revenues from the division of tax by about \$300,000. Issuance of debt is also expected in this area to fund Downtown Hillsboro revitalization projects. Much of these debt proceeds are budgeted as capital reserves.

2022-23 is the seventh year of funding for the North Hillsboro Urban Renewal Area. Property values are increasing in this renewal area which is budgeted about the same as the current year. Significant North Hillsboro area projects are related to land acquisition and road construction for the NE 30th Ave and Huffman St and other Reimbursement District activity.

Staff time is charged to both Urban Renewal areas; however, the FTE reside with the Economic Development Department of the City of Hillsboro. Thus, no FTE's are specifically listed in this public notice.
