

Rate review background

Rate review is conducted on an annual basis

- Goal: Ensure community members are charged reasonable, fair and just rates for garbage & recycling collection services
- Purpose: Review programmatic and financial data submitted by all certificated haulers for accuracy and assessment of trends/industry impacts
- **Desired outcome**: Ensure the financial health of the collection system and adjust rates to target a Return on Revenue.





County conducts annual rate reviews

Annual review of detailed financial information and the collection company's allocations of costs is required

- County provided Detailed Cost Report template
- Data collected is related to wages, labor, finances, equipment, customer accounts, and operational expenses
 - Direct cost –are expenses the company can easily connect or trace to a specific product or service
 - Indirect cost "shared" costs such as office space, or operational cost and equipment used in multiple jurisdictions



County authority to set collection rates

Authority established in County Code:

 Section 8.04.330 provides that increases or decreases in the rates shall not be made by the board unless the board finds that the increase or decrease is based upon an increase or decrease in the cost of doing business or an increased cost of additional, better or more comprehensive service.



Cost of service model

Return on Revenue (ROR) methodology is utilized

Revenues – Expenses = Profit

Profit/Revenues = Return on Revenue

Current target 10% ROR

Balancing the system ROR

Line of service	Revenue needed for 10% ROR	Rate change needed for 10% ROR	Cost to average customer
Residential	\$ 1,005,000	3.60%	\$ 0.96/month, 32 gal
Commercial	\$ 253,500	3.19%	\$ 8.41/month, 4 yds
Drop Box	\$ 414,500	7.66%	\$ 12.82/haul, 10 yd box

Rate setting key considerations

- Variables to determining whether a rate change should be considered
 - Concentration of customer in the area served
 - System impacts (foreseen and not)
 - Methods of collection and transportation
 - Disposal costs
 - Local wage scales
 - Services of management
 - Investment in facilities and equipment
 - Reasonable return on revenue for the haulers
 - Programmatic changes






Urban residential food scrap proposal

Proposed program parameters:

- Bi-weekly collection of residential food scraps
- Material added to the current yard debris cart





Program implementation costs

Staff purpose an additional 1.93% increase for urban residential rates to cover program implementation costs

Urban Residential	Rate change	Cost to average customer
Base increase	3.60%	\$ 0.96 / month, 32 gal
Food waste	1.93%	\$0.48 / month, 32 gal
Total	5.53%	\$ 1.44 / month, 32 gal





- Increase in rates for commercial, drop box and residentials customers
- No changes in rates for medical waste or Recycle+ lines of service

Line of service	% change to return to 10% target ROR	Impact on average collection rate
Commercial (container)	3.60%	\$ (8.41)/month, 4 yds
Drop box/compactor	7.66%	\$ (12.82)/haul, 10 yd box
Rural residential (can/cart)	3.60%	\$ (0.96)/month, 32 gal
Urban residential (can/cart)	5.53%	\$(1.44)/month, 32 gal
